### **III. DISCUSSION OF LEGISLATION**

#### House Bill No. 51 by Representative Goudeau

Representative Goudeau presented House Bill No. 51, which provides relative to vehicular homicide.

Representative Goudeau offered amendments to:

- (1) Add language that provides for an offender's payment of court-ordered restitution to the child of the victim if the offender commits the crime of vehicular homicide;
- (2) Delete language that refers to court-ordered child support restitution payments made to the child support enforcement section of the Department of Children and Family Services;
- (3) Remove all references to child support;
- (4) Add payment of restitution to the penalties of vehicular homicide; and
- (5) Provide that proposed law be referred to as "Cody's Law".

Representative Goudeau offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 11 yeas and 0 nays. Representatives Bacala, Bryant, Goudeau, Marcelle, Marino, McCormick, McKnight, Muscarello, Nelson, Seabaugh, and Villio voted yea.

Representative Marino offered an amendment to make technical changes. Representative Marino offered a motion to adopt the proposed amendment. Without objection, the amendment was adopted by a vote of 11 yeas and 0 nays. Representatives Bacala, Bryant, Goudeau, Marcelle, Marino, McCormick, McKnight, Muscarello, Nelson, Seabaugh, and Villio voted yea.

Representatives Bacala, Bryant, Goudeau, Marcelle, McCormick, McKnight, Muscarello, Nelson, Seabaugh, and Villio voted yea.

Representative Villio offered a motion to report House Bill No. 434 with amendments. Without objection, House Bill No. 434 was reported with amendments by a vote of 9 yeas and 0 nays. Representatives Bacala, Bryant, Goudeau, Marcelle, McCormick, McKnight, Nelson, Seabaugh, and Villio voted yea.

Without objection, the amendment was adopted by a vote of 11 yeas and 0 nays. Representatives Bacala, Bryant, Goudeau, Marcelle, Marino, McCormick, McKnight, Muscarello, Nelson, Seabaugh, and Villio voted yea.

Representative Muscarello offered an amendment to provide for enforcement by a summons in lieu of arrest. Representative Muscarello offered a motion to adopt the proposed amendment. Without objection, the amendment was adopted by a vote of 8 yeas and 0 nays. Representatives Bacala, Bryant, Goudeau, Marcelle, McKnight, Muscarello, Nelson, and Villio voted yea.

Representative McCormick offered a motion to report House Bill No. 54 with amendments. No vote was taken.

At the request of the author, Representative Bacala offered a substitute motion to voluntarily defer action on House Bill No. 54. Without objection, action on House Bill No. 54 was voluntarily deferred by a vote of 9 yeas and 0 nays. Representatives Bacala, Bryant, Goudeau, Marcelle, McCormick, McKnight, Muscarello, Nelson, and Villio voted yea.

Representative Bacala offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 8 yeas and 0 nays. Representatives Bacala, Goudeau, McCormick, McKnight, Muscarello, Nelson, Seabaugh, and Villio voted yea.

Representative Bacala offered a motion to adopt the proposed amendment. Without objection, the amendment was adopted by a vote of 9 yeas and 0 nays. Representatives Bacala, Goudeau, Marino, McCormick, McKnight, Muscarello, Nelson, Seabaugh, and Villio voted yea.

Representatives Bacala, Goudeau, Marino, McCormick, McKnight, Muscarello, Nelson, Seabaugh, and Villio voted yea.

Representative Marino offered a motion to report House Bill No. 134 with amendments. Without objection, House Bill No. 134 was reported with amendments by a vote of 9 yeas and 0 nays. Representatives Bacala, Goudeau, Marino, McCormick, McKnight, Muscarello, Nelson, Seabaugh, and Villio voted yea.
