### III. DISCUSSION OF LEGISLATION

# House Bill No. 769 by Representative Wright

Representative Wright presented House Bill No. 769, which provides relative to ignition interlock devices and maintenance services.

# House Bill No. 471 by Representative Mincey

Representative Mincey presented House Bill No. 471, which provides relative to background checks for workers dressed in costume as certain characters.

On behalf of the author, Representative Bacala offered amendments to:

- (1) Remove the requirement for a background check for volunteers dressed in costumes or as certain characters;
- (2) Provide that proposed law applies to any employee that is eighteen years of age or older;
- (3) Require the background check before initial employment;
- (4) Require employees to submit a background check for continuous employment;
- (5) Remove proposed law penalties for employees;
- (6) Provide that the employer who knowingly employs a sex offender shall not be fined more than five thousand dollars; and
- (7) Require certain qualified entities to conduct an additional background check every five years.

Representative Bacala offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 10 yeas and 0 nays. Representatives Bacala, Bryant, Fontenot, Goudeau, Marino, McCormick, McKnight, Muscarello, Seabaugh, and Villio voted yea.

Representative Bacala offered an amendment to add the requirement that the person is employed for the primary purpose of interacting with children. Representative Bacala offered a motion to adopt the proposed amendment. Without objection, the amendment was adopted by a vote of 10 yeas and

0 nays. Representatives Bacala, Bryant, Fontenot, Goudeau, Marino, McCormick, McKnight, Muscarello, Seabaugh, and Villio voted yea.

Sarah Whittington, Justice and Accountability Center, 4035 Washington Ave., Ste. 203, New Orleans, LA 70125, (504) 322-4000, spoke in opposition to House Bill No. 471.

Representative Seabaugh offered a motion to report House Bill No. 471 with amendments, to which Representative Fontenot objected. The administrative assistant called the roll, and the motion failed to pass by a vote of 4 yeas and 7 nays. Representatives Bacala, Marino, Muscarello, and Seabaugh voted yea. Representatives Bryant, Fontenot, Goudeau, Marcelle, McCormick, McKnight, and Villio voted nay.

# **House Bill No. 731 by Representative Duplessis**

Representative Duplessis presented House Bill No. 731, which provides relative to emergency preparedness plans for juvenile detention facilities.

On behalf of the author, Representative Bacala offered amendments to:

- (1) Replace references to the Department of Public Safety and Corrections with the Department of Children and Family Services and Office of Juvenile Justice; and
- (2) Make written policies, procedures, and practices applicable to juvenile detention centers.

Representative Bacala offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 8 yeas and 0 nays. Representatives Bacala, Bryant, Fontenot, Marcelle, McCormick, McKnight, Muscarello, and Villio voted yea.

Representative Marcelle offered a motion to report House Bill No. 731 with amendments. Without objection, House Bill No. 731 was reported with amendments by a vote of 10 yeas and 0 nays. Representatives Bacala, Bryant, Fontenot, Goudeau, Marcelle, Marino, McCormick, Muscarello, Seabaugh, and Villio voted yea.

# **House Bill No. 707 by Representative Duplessis**

Representative Duplessis presented House Bill No. 707, which provides relative to the expungement of criminal records.

On behalf of the author, Representative Bacala offered amendments to:

- (1) Require the Louisiana Supreme Court Case Management Information System to send notice by United States mail or electronically of all records identified pursuant to proposed law to be expunged to the clerks of the district courts;
- (2) Remove the requirement for the bureau to identify records as expunged by automation and require the clerks of the district courts to verify and identify such records;
- (3) Require the clerks of the district courts to also send notice by United States mail or electronically of all records expunged by automation to the Louisiana Supreme Court Case Management and Information System and the bureau; and
- (4) Require the Louisiana Supreme Court Case Management and Information System and the bureau to identify records as expunged by automation.

Representative Bacala offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 8 yeas and 0 nays. Representatives Bacala, Bryant, Goudeau, Marcelle, Marino, McCormick, Muscarello, and Seabaugh voted yea.

Representative Bacala offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 8 yeas and 0 nays. Representatives Bacala, Fontenot, Goudeau, McCormick, Muscarello, Nelson, Seabaugh, and Villio voted yea.

Representative Bryant offered a motion to report House Bill No. 722 with amendments, to which Representative Villio objected. The administrative assistant called the roll, and the motion failed to pass by a vote of 3 yeas and 7 nays. Representatives Bryant, Marcelle, and Marino voted yea. Representatives Bacala, Fontenot, Goudeau, McCormick, Nelson, Seabaugh, and Villio voted nay.
