III. DISCUSSION OF LEGISLATION

House Bill No. 577 by Representative Willard

At the request of the author, Representative Bacala offered a motion to voluntarily defer action on House Bill No. 577, which would provide relative to rulings or holdings of the U.S. Supreme Court or Louisiana Supreme Court regarding criminal procedure. Without objection, action on House Bill No. 577 was voluntarily deferred by a vote of 7 yeas and 0 nays. Representatives Bacala, Fontenot, Garofalo, Goudeau, Muscarello, Nelson, and Villio voted yea.

House Bill No. 40 by Representative Cormier

Representative Cormier presented House Bill No. 40, which provides relative to evidence that is admissible.

Representatives Bacala, Fontenot, Garofalo, Goudeau, Muscarello, Nelson, Seabaugh, and Villio voted yea. Representative Marcelle voted nay.

House Bill No. 483 by Representative Travis Johnson

Representative Travis Johnson presented House Bill No. 483, which provides relative to the restoration of gun rights.

On behalf of the author, Representative Bacala offered amendments to:

- (1) Make technical changes;
- (2) Delete provisions referring to R.S. 14:95.1; and
- (3) Add language that clarifies that the proposed law waiting period of five years pertaining to eligibility for a concealed handgun permit is not applicable to a person otherwise prohibited from possessing a firearm by state law.

Representative Bacala offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 8 yeas and 0 nays. Representatives Bacala, Garofalo, Goudeau, Marcelle, McCormick, Muscarello, Seabaugh, and Villio voted yea.

Representatives Bacala, Fontenot, Garofalo, Goudeau, McCormick, Muscarello, Nelson, Seabaugh, and Villio voted yea. Representative Marcelle voted nay.

Representative Marcelle offered a motion to report House Bill No. 964 favorably, to which Representative Villio objected. The administrative assistant called the roll, and the motion failed to

pass by a vote of 4 yeas and 6 nays. Representatives Marcelle, Marino, Muscarello, and Nelson voted yea. Representatives Bacala, Fontenot, Garofalo, Goudeau, McCormick, and Villio voted nay.

House Bill No. 102 by Representative Muscarello

Representative Muscarello presented House Bill No. 102, which provides relative to parole hearings.

Representative Muscarello offered an amendment to provide that the committee on parole shall not consider a parole rehearing of any prisoner serving a sentence for the following offenses until at least four years after the denial of parole:

- (1) Any crime of violence or sex offense, for which the prisoner is serving a life sentence and for which the prisoner is eligible for parole;
- (2) Any crime that is both a crime of violence and a sex offense, for which the prisoner is serving a fixed term of years and for which the prisoner is eligible for parole; and
- (3) Manslaughter, for which the prisoner is eligible for parole.

Muscarello offered a motion to adopt the proposed amendment. Without objection, the amendment was adopted by a vote of 7 yeas and 0 nays. Representatives Bacala, Fontenot, Garofalo, Marino, Muscarello, Nelson, and Villio voted yea.

Gwendolyn Gagliano, no address provided, (985) 974-2016, spoke in support of House Bill No. 102.

Representative Nelson offered an amendment to provide that the provisions shall be given prospective application only. After discussion, Representative Nelson withdrew the amendment.

On behalf of the author, Representative Bacala offered amendments to:

- (1) Provide that an inmate housed at a state correctional facility shall not be required to make a copayment of an amount greater than two dollars upon receiving medical or dental treatment.
- (2) Provide that an inmate housed at a state correctional facility shall not be charged for prescriptions written and dispensed.
- (3) Provide that an inmate who has two hundred dollars or less in a drawing account shall not be required to make a copayment of any amount upon receiving medical or dental treatment.
- (4) Restore the present law provisions relative to the withdrawal of funds in an inmate's compensation account to satisfy medical or dental copays.

Representative Bacala offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 8 yeas and 0 nays. Representatives Bacala, Fontenot, Garofalo, Marcelle, Marino, McCormick, Seabaugh, and Villio voted yea.

Representative Marcelle offered a motion to report House Bill No. 175 with amendments, to which Representative Villio objected. The administrative assistant called the roll, and the motion failed to pass by a vote of 5 yeas and 5 nays. Representatives Bacala, Marcelle, Marino, McCormick, and Nelson voted yea. Representatives Fontenot, Garofalo, Goudeau, Seabaugh, and Villio voted nay.

House Bill No. 129 by Representative Nelson

Representative Nelson presented House Bill No. 129, which provides relative to an arrested person's failure to honor a written promise to appear.

Representative Nelson offered amendments to:

- (1) Restore present law (R.S. 32:57.1) and provide that:
 - (a) The Department of Public Safety and Corrections shall notify the arrested person by certified mail return receipt requested that his operator's license may be suspended for failure to honor a written promise or payment of a fine within 180 days after the date notice was received.
 - (b) Remove <u>present law</u> which provides that the operator's license of the arrested person cannot be renewed or reissued.

- (c) Provide that upon payment of \$100 to the Department of Public Safety and Corrections, the license of the arrested person shall be released from pending suspension, renewed, or reissued.
- (d) Provide that if failure to appear is the result of incarceration, the operator's license of an arrested person shall be renewed and reissued without payment for any suspension.
- (2) Remove <u>proposed law</u> (R.S. 32:391) relative to persons who willfully violate a written promise to appear.

Representative Nelson offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 9 yeas and 0 nays. Representatives Bacala, Fontenot, Garofalo, Goudeau, Marino, McCormick, Muscarello, Nelson, and Seabaugh voted yea.
