Senate Bill No. 314 by Senator Cortez

Senator Cortez presented Senate Bill No. 314, which provides relative to historic horse racing.

Representative Davis offered amendments to allow the commission to make rules governing, permitting, and regulating the wagering on horse races under the form of mutuel wagering by patrons, known as pari-mutuel wagering, whether on live or historical horse races, and to make technical changes. Representative Davis offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 10 yeas and 0 nays. Representatives Davis, Fontenot, Goudeau, Jordan, McKnight, Newell, Pressly, St. Blanc, Tarver, and Thomas voted yea.
