III. DISCUSSION OF LEGISLATION

Representative Charles Owen offered a motion to adopt a three-minute rule for presenters, witnesses, and members to speak. Without objection, the motion passed by a vote of 9 yeas and 0 nays. Representatives Harris, Amedée, Freeman, Freiberg, Jefferson, Charles Owen, Phelps, St. Blanc, and Tarver voted yea.

House Concurrent Resolution No. 1 by Representative Ivey

Representative Ivey presented House Concurrent Resolution No. 1, which suspends provisions of law authorizing the exclusion of unimmunized persons from in-person attendance at schools and day care centers under certain circumstances.

Representative Harris offered amendments that modified the "whereas" provisions of House Concurrent Resolution No. 1. Representative Harris offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 7 yeas and 0 nays. Representatives Harris, Amedée, Freiberg, Jefferson, Charles Owen, St. Blanc, and Tarver voted yea.

Representative Amedée presented House Bill No. 427, which prohibits the administration of vaccines to minors on school property and at school-sponsored events.

Representative Hilferty offered amendments to allow vaccine administration if parental consent has been obtained and verified multiple ways and there is a healthcare professional present. Representative Hilferty offered a motion to adopt the proposed amendments, to which Representative Brass objected. The administrative assistant called the roll, and the amendments were adopted by a vote of 6 yeas, 4 nays, and 1 abstention. Representatives Amedée, Emerson, Hilferty, Charles Owen, St. Blanc, and Tarver voted yea. Representatives Brass, Freeman, Freiberg, and Phelps voted nay. Representative Harris abstained.

- 1. Removed the eligibility requirement that students are above the average age for their grade.
- 2. Specified that students in alternative schools and alternative educational placements may be eligible students.

Representative Phelps offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 8 yeas and 0 nays. Representatives Harris, Amedée, Brass, Freiberg, Jefferson, Charles Owen, Phelps, and Tarver voted yea.

Representative Jefferson offered amendments that:

- 1. Revised present law to lower the minimum age for initial qualification for an M.J. Foster Promise award from 21 to 18 beginning with the 2023-2024 academic year.
- 2. Removed proposed law that would have lowered the minimum ACT score needed for qualification for a TOPS-Tech Award.

Representative Jefferson offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 12 yeas and 0 nays. Representatives Harris, Amedée, Brass, Emerson, Freeman, Freiberg, Hilferty, Jefferson, Charles Owen, Phelps, St. Blanc, and Tarver voted yea.
