III. DISCUSSION OF LEGISLATION

House Bill No. 202 by Representative Mike Johnson

House Bill No. 202 requires political committees to include specified information on the statement of organization.

Representative Stefanski offered a motion to voluntarily defer action on House Bill No. 202. Without objection, action on House Bill No. 202 was voluntarily deferred by a vote of 11 yeas and 0 nays. Representatives Stefanski, Beaullieu, Farnum, Gadberry, Hodges, Horton, Ivey, Jenkins, Newell, Thomas, and White voted yea.

Representative Villio presented House Bill No. 188, which provides relative to prohibitions and requirements for digital material of a political nature.

- (1) Provided that all rules sunset by June 30 of the year following adoption unless the legislature acted to continue the rule;
- (2) Required legislative oversight hearings prior to the convening of the regular legislative session of each year on all rules that were adopted in the previous year to determine if the rules should be continued; and
- (3) Required legislation to authorize the continued effectiveness of such rules.

Representative Stefanski offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 11 yeas and 0 nays. Representatives Stefanski, Duplessis, Farnum, Gadberry, Ivey, Jenkins, LaCombe, Lyons, Magee, Thomas, and White voted yea.

Representatives Stefanski, Duplessis, Farnum, Gadberry, Hodges, Horton, Ivey, Jenkins, LaCombe, Magee, Newell, Thomas, and White voted yea.

Representative Jenkins offered a motion to report House Bill No. 206 with amendments, to which Representative Thomas objected. The administrative assistant called the roll, and House Bill No. 206 was reported with amendments by a vote of 9 yeas, 3 nays, and 1 abstention. Representatives Duplessis, Farnum, Gadberry, Ivey, Jenkins, LaCombe, Magee, Newell, and White voted yea. Representatives Hodges, Horton, and Thomas voted nay. Representative Stefanski abstained.

Representatives Stefanski, Beaullieu, Wilford Carter, Duplessis, Farnum, Gadberry, Hodges, Horton, Jenkins, LaCombe, Magee, Newell, Thomas, and White voted yea.

- (4) Allowed the Supervisory Committee on Campaign Finance Disclosure to deliver notices relative to annual reports to certain candidates via electronic mail.
