III. DISCUSSION OF LEGISLATION

House Bill No. 582 by Representative Stagni

Representative Stagni presented House Bill No. 582, which joins Louisiana to the licensed professional counselors interstate compact.

House Bill No. 262 by Representative Marino

Representative Marino presented House Bill No. 262, which provides relative to exceptions to the public records law.

Representative Stefanski offered amendments that expanded the present law public records exception for attorney and expert work product that reflect the mental impressions, conclusions, opinions, or theories to also include those of a district attorney investigator or a district attorney victims assistance coordinator rather than creating a new exception for the mental impressions, conclusions, opinions, or theories of any district attorney, assistant district attorney, district attorney investigator, or district attorney victims assistance coordinator.

Representative Stefanski offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 10 yeas and 0 nays. Representatives Stefanski, Beaullieu, Duplessis, Gadberry, Horton, Jenkins, LaCombe, Lyons, Newell, and Thomas voted yea.

Representative Newell offered a motion to report House Bill No. 262 with amendments, to which Representative Magee objected. No vote was taken.

Representative Stefanski offered a substitute motion to voluntarily defer action on House Bill No. 262. Without objection, action on House Bill No. 262 was voluntarily deferred by a vote of 10 yeas and 0 nays. Representatives Stefanski, Duplessis, Gadberry, Ivey, Jenkins, Mike Johnson, LaCombe, Lyons, Magee, and Thomas voted yea.

House Bill No. 473 by Representative Duplessis

Representative Duplessis presented House Bill No. 473, which provides relative to fees for production of public records.

Representative Duplessis offered amendments to retain present law, which authorizes rather than requires custodians to charge a fee for copies of public records. Representative Duplessis offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 11 yeas and 0 nays. Representatives Beaullieu, Duplessis, Gadberry, Horton, Ivey, Jenkins, Mike Johnson, LaCombe, Lyons, Magee, and Thomas voted yea.

- (2) Made technical changes.
