III. DISCUSSION

Representative Zeringue, chairman of the Judicial Structure Task Force, asked the staff members of the judicial administrator's office of the Louisiana Supreme Court to provide an update on finalizing the National Center for State Courts (NCSC) contract, collecting data, and establishing the advisory committees.

Kerry K. Lentini, contractor, representing the Louisiana Supreme Court, 300 Southern Rd., River Ridge, LA 70123, (504) 400-4499, testified for information only and addressed questions from the task force members.

Amanda Trapp, legislative analyst, stated that the money for the contract was appropriated to the Legislative Budgetary Control Council, so the legislature is working with the judicial administrator's office to finalize the contract.

Representative Zeringue asked Ms. Lentini, going back to 2014, if the historical data would be needed by NCSC to start the study. She stated that the NCSC could begin the process as soon as the contract is signed.
