Minutes of Meeting 2022 Regular Session April 7, 2022

III. DISCUSSION OF LEGISLATION

House Bill No. 647 by Representative Hilferty

On behalf of Representative Hilferty, Representative Willard presented House Bill No. 647, which provides relative to the Mid-City Security District in Orleans Parish.

Representative Willard offered a motion to report House Bill No. 647 favorably. Without objection, House Bill No. 647 was reported favorably by a vote of 11 yeas and 0 nays. Representatives Edmonds, DuBuisson, Farnum, Fontenot, Freiberg, Gadberry, McKnight, Newell, Schamerhorn, Stagni, and Willard voted yea.

House Bill No. 72 by Representative Magee

On behalf of Representative Magee, Representative Fontenot presented House Bill No. 72, which provides relative to the board of commissioners of Terrebonne Parish Fire Protection District Number Six.

Representative Fontenot offered a motion to report House Bill No. 72 favorably. Without objection, House Bill No. 72 was reported favorably by a vote of 11 yeas and 0 nays. Bill Salmeron, New Orleans Emergency Medical Services, 2929 Earhart Boulevard, New Orleans, LA 70125, (504) 250-2378, spoke in support of House Bill No. 392.

Representative Edmonds offered amendments that:

- 1. Made the bill applicable to employees who are emergency public safety telecommunicators rather than emergency response operators or emergency services dispatchers.
- 2. Made the bill permissive rather than mandatory.
- 3. Removed the definition of first responder.

Representative Edmonds offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 13 yeas and 0 nays. Representatives Edmonds, DuBuisson, Farnum, Fontenot, Freiberg, Gadberry, Kerner, Lyons, McKnight, Newell, Schamerhorn, Stagni, and Willard voted yea.

Representative Farnum offered a motion to report House Bill No. 392 with amendments. Without objection, House Bill No. 392 was reported with amendments by a vote of 13 yeas and 0 nays. Representatives Edmonds, DuBuisson, Farnum, Fontenot, Freiberg, Gadberry, Kerner, Lyons, McKnight, Newell, Schamerhorn, Stagni, and Willard voted yea.
