### House Bill No. 144 by Representative Thomas

Representative Thomas presented House Bill No. 144, which provides relative to reporting requirements for persons convicted of production or manufacturing of methamphetamine.

Representative Seabaugh offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 8 yeas, 0 nays, and 1 abstention. Representatives Bryant,

Edmonston, Fontenot, Garofalo, Goudeau, Horton, Seabaugh, and Villio voted yea. Representative Marino abstained.
