III. DISCUSSION OF LEGISLATION

Representative Bacala in the chair.

House Bill No. 556 by Representative Davis

Representative Davis presented House Bill No. 556, which provides relative to electronic monitoring.

On behalf of the author, Representative Villio offered amendments to:

- (1) Make technical changes;
- (2) Provide relative to the present law crime of "tampering with electronic monitoring equipment", create a new penalty provision consisting of a fine of not more than \$1,000 and imprisonment at hard labor not more than one year for any offender who violates present law after being released pursuant to a bail undertaking for a felony crime of violence enumerated or defined in present law (R.S. 14:2(B));
- (3) Clarify that the policies and procedures governing the availability, storage, and use of electronic monitoring equipment shall include alert notifications from the office of technology services to an authorizing judge of law enforcement agency;
- (4) Provide for additional policies and procedures;
- (5) Provide for a reporting requirement for electronic monitoring service providers and the court exercising jurisdiction over the monitored individual;
- (6) Establish a civil fine of not more than \$1,000 for electronic monitoring service providers who intentionally withhold or intentionally fail to timely report information required by proposed law and prohibit any violators from conducting business in Louisiana;
- (7) Require all providers who provide electronic monitoring services in Louisiana to register with the Department of Public Safety and Corrections; and

(8) Require the Department of Public Safety and Corrections to suspend or revoke the approval of a electronic monitoring service provider at any time the department determines that the provider has intentionally withheld or intentionally failed to timely report information required by proposed law.

Representative Villio offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 9 yeas and 0 nays. Representatives Bacala, Edmonston, Fontenot, Goudeau, Horton, Knox, Marcelle, Seabaugh, and Villio voted yea.

- (1) Provide relative to the present law rules for separate standards for facilities utilized for pre-adjudication juvenile detention, delete the proposed law provision relative to post-adjudication detention; and
- (2) Provide that pre-adjudication standards for juvenile detention facilities shall allow the local existing facilities to be utilized with minimal additional costs when it is determined that the economic impact is sufficiently great to make compliance impractical.

Representative Bacala offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 9 yeas and 0 nays. Representatives Bacala, Bryant, Edmonston, Fontenot, Goudeau, Horton, Knox, LaFleur, and Villio voted yea.

On behalf of the author, Representative Bacala offered amendments to:

(1) Make technical changes;

- (2) Change the provision of present law relative to the transfer of juveniles for criminal prosecution from permissive to mandatory for all subsequent procedures if an indictment is returned or a bill of information is filed;
- (3) Change the length of time that a juvenile may be held in an adult jail or lockup from twenty four hours to forty eight hours if certain conditions occur; and
- (4) Change the length of time for the occurrence of the continued custody hearing from twenty-four hours to forty-eight hours.

Representative Bacala offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 9 yeas and 0 nays. Representatives Bacala, Bryant, Edmonston, Fontenot, Goudeau, Horton, Knox, LaFleur, and Villio voted yea.

- (2) Require the motion to be served upon the opposing counsel or party, if unrepresented; and
- (3) Provide that the court is not required to set a motion to modify unless the motion alleges facts that would warrant a modification of the existing bail amount or conditions.

House Bill No. 237 by Representative Schamerhorn

Representative Schamerhorn presented House Bill No. 237, which provides relative to certain activities regarding contraband.

On behalf of the author, Representative Villio offered amendments to:

- (1) Remove proposed law language relative to the "taking" of contraband;
- (2) Provide that sacramental wine shall be permitted by the warden or his designee;
- (3) Remove proposed law language relative to the intention for use in the planning or aiding in an escape or attempt to escape from any facility; and
- (4) Add hypodermic syringes, needles, and other objects used, intended for use, or designed for use in injecting controlled dangerous substances into the human body as contraband.

Representative Villio offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 8 yeas, 0 nays, and 1 abstention. Representatives Bacala, Edmonston, Fontenot, Garofalo, Goudeau, Horton, Seabaugh, and Villio voted yea. Representative Marino abstained.

Representative Bacala offered a motion to report House Bill No. 237 with amendments. Without objection, House Bill No. 237 was reported with amendments by a vote of 7 yeas, 0 nays, and 1 abstention. Representatives Bacala, Edmonston, Garofalo, Goudeau, Horton, Seabaugh, and Villio voted yea. Representative Marino abstained.

House Bill No. 96 by Representative Thomas

Representative Thomas presented House Bill No. 96, which provides relative to penalties and responsive verdicts for negligent homicide.

On behalf of the author, Representative Marino offered amendments to:

- (1) Make technical changes;
- (2) Remove the proposed law definition of "firearm" from the present law list of definitions;
- (3) Remove proposed law provisions relative to the penalty for the killing of a human being that is proximately or caused directly by the discharge of a firearm; and
- (4) Remove present law provisions relative to responsive verdicts.

Representative Marino offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 7 yeas, 0 nays, and 1 abstention. Representatives Bacala, Edmonston, Garofalo, Goudeau, Horton, Seabaugh, and Villio voted yea. Representative Marino abstained.

Representative Bacala offered a motion to adopt the proposed amendment. Without objection, the amendment was adopted by a vote of 10 yeas, 0 nays, and 1 abstention. Representatives Bacala, Edmonston, Fontenot, Garofalo, Goudeau, Hodges, Horton, Muscarello, Seabaugh, and Villio voted yea. Representative Marino abstained.

Representative Marino offered an amendment to change the location provision in proposed law from "one square mile" to "one thousand feet". Representative Marino offered a motion to adopt the proposed amendment, to which Representative Villio objected. The administrative assistant called the roll, and the motion failed to pass by a vote of 0 yeas, 10 nays, and 1 abstention. Representatives Bacala, Edmonston, Fontenot, Garofalo, Goudeau, Hodges, Horton, Muscarello, Seabaugh, and Villio voted nay. Representative Marino abstained.

Representatives Bacala, Fontenot, Garofalo, Goudeau, Hodges, Horton, Muscarello, Seabaugh, and Villio voted yea. Representative Marino abstained.
