### III. DISCUSSION OF LEGISLATION

# Senate Concurrent Resolution No. 45 by Senator Abraham

Senator Abraham presented Senate Concurrent Resolution No. 45, which creates the Task Force on Sentencing for Second Degree Murder to determine the best changes to sentencing for second degree murder.

John Sinquefield, chief deputy, Louisiana Attorney General's Office, 1885 N. 3rd St., Baton Rouge, LA 70802, (225) 337-5991, spoke in opposition to Senate Concurrent Resolution No. 45.

Representative Bacala offered an amendment to add an attorney from the office of the attorney general as a member of the task force. Representative Bacala offered a motion to adopt the proposed amendment. Without objection, the amendment was adopted by a vote of 10 yeas, 0 nays, and 1 abstention. Representatives Bacala, Bryant, Edmonston, Fontenot, Garofalo, Goudeau, Horton, Knox, Muscarello, and Villio voted yea. Representative Marino abstained.

Representative Villio offered an amendment to clarify that second degree murder committed in the course of a felony, but without the intent to kill or inflict harm, bares further study. Representative Villio offered a motion to adopt the proposed amendment. Without objection, the amendment was adopted by a vote of 10 yeas, 0 nays, and 1 abstention. Representatives Bacala, Bryant, Edmonston, Fontenot, Garofalo, Goudeau, Horton, Knox, Muscarello, and Villio voted yea. Representative Marino abstained.

Representative Villio offered an amendment to remove language relative to second degree murder with specific intent to kill or inflict great bodily harm. Representative Villio offered a motion to adopt the proposed amendment. Without objection, the amendment was adopted by a vote of 8 yeas, 0 nays, and 1 abstention. Representatives Bacala, Bryant, Edmonston, Fontenot, Horton, Knox, Muscarello, and Villio voted yea. Representative Marino abstained.

Representative Knox offered a motion to report Senate Concurrent Resolution No. 45 with amendments. Without objection, Senate Concurrent Resolution No. 45 was reported with

amendments by a vote of 8 yeas, 0 nays, and 1 abstention. Representatives Bacala, Bryant, Edmonston, Fontenot, Horton, Knox, Muscarello, and Villio voted yea. Representative Marino abstained.

### Senate Bill No. 117 by Senator Harris

Senator Harris presented Senate Bill No. 117, which provides relative to the crime of assault by drive-by shooting.

Representative Bacala offered a motion to report Senate Bill No. 117 favorably. Without objection, Senate Bill No. 117 was reported favorably by a vote of 10 yeas, 0 nays, and 1 abstention. Representatives Bacala, Bryant, Edmonston, Fontenot, Garofalo, Horton, Knox, Marcelle, Muscarello, and Villio voted yea. Representative Marino abstained.

Representative Marcelle offered a motion to report Senate Bill No. 111 with amendments. Without objection, Senate Bill No. 111 was reported with amendments by a vote of 8 yeas, 0 nays, and 1 abstention. Representatives Bacala, Edmonston, Fontenot, Horton, Knox, Marcelle, Seabaugh, and Villio voted yea. Representative Marino abstained.

Representative Selders presented House Bill No. 318, which provides relative to automatic weapons.

At the request of the author, Representative Marcelle offered a motion to voluntarily defer action on House Bill No. 318. Without objection, action on House Bill No. 318 was voluntarily deferred by a vote of 8 yeas, 0 nays, and 1 abstention. Representatives Bacala, Bryant, Garofalo, Horton, Knox, Marcelle, Seabaugh, and Villio voted yea. Representative Marino abstained.
