Senate Bill No. 189 by Senator Jackson

Senator Jackson presented Senate Bill No. 189, which provides relative to electronic or video bingo machines and licensed premises.

On behalf of the author, Representative LaFleur offered amendments to:

- (1) Prohibit the office of charitable gaming from issuing any new license or permit after June 30, 2022, for the placement of electronic or video bingo machines within one mile from property on the National Register of Historic Places, public playgrounds, residential property, or any building used primarily as a church, synagogue, public library, or school;
- (2) Provide that the proposed law placement of electronic or video bingo machines does not apply to the following:
 - (a) Locations that are damaged or destroyed due to an act of God, natural disaster, force majeure, catastrophic event, or action by a governmental body;
 - (b) Any location licensed to conduct electronic video bingo on or before June 30, 2022; and
- (3) Define "residential property".

Representative LaFleur offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 13 yeas, 0 nays, and 1 abstention. Representatives Bacala, Bryant, Edmonston, Fontenot, Goudeau, Hodges, Horton, Knox, LaFleur, Marcelle, Muscarello, Seabaugh, and Villio voted yea. Representative Marino abstained.

Representative Bryant offered a motion to report Senate Bill No. 189 with amendments. Without objection, Senate Bill No. 189 was reported with amendments by a vote of 12 yeas, 0 nays, and 1 abstention. Representatives Bacala, Bryant, Edmonston, Fontenot, Goudeau, Horton, Knox, LaFleur, Marcelle, Muscarello, Seabaugh, and Villio voted yea. Representative Marino abstained.

Representative Seabaugh offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 12 yeas, 0 nays, and 1 abstention. Representatives Bryant, Edmonston, Fontenot, Garofalo, Goudeau, Horton, Knox, LaFleur, Marcelle, Muscarello, Seabaugh, and Villio voted yea. Representative Marino abstained.

- (3) Authorize local governments to enact ordinances to prohibit the sale or distribution of mitragynine speciosa or to regulate the sale or distribution of such products in a more restrictive manner than proposed law.

Representatives Bacala, Edmonston, Garofalo, Goudeau, Horton, Knox, LaFleur, Seabaugh, and Villio voted yea. Representative Marino abstained.
