III. DISCUSSION OF LEGISLATION

House Bill No. 176 by Representative Jefferson

Representative Jefferson presented House Bill No. 176, which provides relative to transfer of ownership of movable property.

Professor Melissa Lonegrass, Louisiana State Law Institute, Room W127, LSU Law Center, 1 E. Campus Dr., Baton Rouge, LA 70802, (225) 578-0200, spoke for information only on House Bill No. 176.

Representative Jefferson offered amendments to amend Civil Code Article 525 to read affirmatively as opposed to providing for the inapplicability of provisions as they apply to proposed law and to make technical changes. Representative Jefferson offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 11 yeas, 0 nays, and 1 abstention. Representatives Amedee, Boyd, Echols, Frieman, Hodges, Jefferson, Jenkins, Mike Johnson, Knox, Muscarello, and Seabaugh voted yea. Representative Gregory Miller abstained.

Representative Jefferson offered a motion to report House Bill No. 176 with amendments. Without objection, House Bill No. 176 was reported with amendments by a vote of 12 yeas, 0 nays, and 1 abstention. Representatives Amedee, Boyd, Echols, Frieman, Hodges, Jefferson, Jenkins, Mike Johnson, Knox, Muscarello, Nelson, and Seabaugh voted yea. Representative Gregory Miller abstained.

Senate Bill No. 63 by Senator Mizell

Senator Mizell presented Senate Bill No. 63, a constitutional amendment, which provides that the right of freedom of worship in churches or other places of worship is a fundamental right that is worthy of the highest order of protection.

Representative Gregory Miller offered a motion to adopt the House Rule 6.8(A) Report for Senate Bill No. 63, which stated that this measure could not be accomplished statutorily and would, therefore, require a constitutional amendment. Without objection, the House Rule 6.8(A) Report to Senate Bill No. 63 was adopted by a vote of 9 yeas, 0 nays, and 1 abstention. Representatives Amedee, Boyd, Echols, Frieman, Hodges, Jefferson, Jenkins, Mike Johnson, and Seabaugh voted yea. Representative Gregory Miller abstained.

Representative Frieman offered a motion to report Senate Bill No. 63 without amendments. Without objection, Senate Bill No. 63 was reported without amendments by a vote of 9 yeas, 0 nays, and 1 abstention. Representatives Amedee, Boyd, Echols, Frieman, Hodges, Jefferson, Jenkins, Mike Johnson, and Seabaugh voted yea. Representative Gregory Miller abstained.

House Bill No. 244 by Representative Bishop

On behalf of Representative Bishop, Representative Gregory Miller presented House Bill No. 244, a constitutional amendment, which provides relative to the Revenue Stabilization Trust Fund.

Representative Gregory Miller offered an amendment to change the ballot language. Representative Gregory Miller offered a motion to adopt the proposed amendment. Without objection, the amendment was adopted by a vote of 9 yeas, 0 nays, and 1 abstention. Representatives Amedee, Boyd, Echols, Emerson, Frieman, Jefferson, Jenkins, Mike Johnson, and Knox voted yea. Representative Gregory Miller abstained.

Representative Gregory Miller offered a motion to adopt the House Rule 6.8(A) Report to House Bill No. 244, which stated that this measure could not be accomplished statutorily and would, therefore, require a constitutional amendment. Without objection, the House Rule 6.8(A) Report to House Bill No. 244 was adopted by a vote of 10 yeas, 0 nays, and 1 abstention. Representatives Amedee, Boyd, Echols, Emerson, Frieman, Jefferson, Mike Johnson, Knox, Muscarello, and Seabaugh voted yea. Representative Gregory Miller abstained.

Representative Gregory Miller offered a motion to report House Bill No. 244 with amendments. Without objection, House Bill No. 244 was reported with amendments by a vote of 10 yeas, 0 nays,

and 1 abstention. Representatives Amedee, Boyd, Echols, Emerson, Frieman, Jefferson, Mike Johnson, Knox, Muscarello, and Seabaugh voted yea. Representative Gregory Miller abstained.

Representative Gregory Miller in the chair.

House Bill No. 400 by Representative Glover

Representative Glover presented House Bill No. 400, a constitutional amendment, which provides relative to the membership of the Louisiana State University and Southern University boards of supervisors.

Representative Emerson offered an amendment to change the ballot language. Representative Emerson offered a motion to adopt the proposed amendment. Without objection, the amendment was adopted by a vote of 10 yeas, 0 nays, and 1 abstention. Representatives Amedee, Boyd, Echols, Emerson, Frieman, Jefferson, Jenkins, Mike Johnson, Knox, and Seabaugh voted yea. Representative Gregory Miller abstained.

Representative Gregory Miller offered a motion to adopt the House Rule 6.8(A) Report to House Bill No. 400, which stated that the measure, in part, could not be accomplished statutorily and would, therefore, require a constitutional amendment. Without objection, the House Rule 6.8(A) Report to House Bill No. 400 was adopted by a vote of 10 yeas, 0 nays, and 1 abstention. Representatives Amedee, Boyd, Emerson, Frieman, Hodges, Jefferson, Jenkins, Mike Johnson, Knox, and Seabaugh voted yea. Representative Gregory Miller abstained.

Representative Emerson offered a motion to report House Bill No. 400 with amendments. Without objection, House Bill No. 400 was reported with amendments by a vote of 9 yeas, 0 nays, and 1 abstention. Representatives Amedee, Boyd, Emerson, Frieman, Hodges, Jefferson, Jenkins, Knox, and Seabaugh voted yea. Representative Gregory Miller abstained.

House Bill No. 487 by Representative Ivey

Representative Ivey presented House Bill No. 487, a constitutional amendment, which provides relative to the vote requirements for certain tax legislation.

Representative Gregory Miller offered an amendment to change the ballot language. Representative Gregory Miller offered a motion to adopt the proposed amendment. Without objection, the amendment was adopted by a vote of 9 yeas, 0 nays, and 1 abstention. Representatives Amedee, Boyd, Emerson, Hodges, Jefferson, Jenkins, Mike Johnson, Knox, and Seabaugh voted yea. Representative Gregory Miller abstained.

Representative Gregory Miller offered a motion to adopt the House Rule 6.8(A) Report to House Bill No. 487, which stated that the measure could not be accomplished statutorily and would, therefore, require a constitutional amendment. Without objection, the House Rule 6.8(A) Report to House Bill No. 487 was adopted by a vote of 9 yeas, 0 nays, and 1 abstention. Representatives Amedee, Boyd, Emerson, Jefferson, Jenkins, Mike Johnson, Knox, Nelson, and Seabaugh voted yea. Representative Gregory Miller abstained.

Representative Amedee offered a motion to report House Bill No. 487 with amendments. Without objection, House Bill No. 487 was reported with amendments by a vote of 9 yeas, 0 nays, and 1 abstention. Representatives Amedee, Boyd, Emerson, Jefferson, Jenkins, Mike Johnson, Knox, Nelson, and Seabaugh voted yea. Representative Gregory Miller abstained.

House Bill No. 537 by Representative Hodges

Representative Hodges presented House Bill No. 537, which provides for a prohibition against foreign adversary purchasing, leasing, or acquiring land.

Representative Gregory Miller offered amendments to:

- (1) Change the disbursement of the proceeds from judicial sales to include certain veterans.
- (2) Authorize the attorney general to enter into cooperative endeavor agreements.
- (3) Provide exceptions for certain persons.
- (4) Change definition of "person connected with a foreign adversary".
- (5) Make technical changes.

Representative Gregory Miller offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 11 yeas, 0 nays, and 1 abstention. Representatives Amedee, Boyd, Emerson, Frieman, Hodges, Jefferson, Mike Johnson, Knox, Muscarello, Nelson, and Seabaugh voted yea. Representative Gregory Miller abstained.

Representative Gregory Miller offered amendments to:

- (1) Provide for notice of attorney general actions.
- (2) Provide that mortgage servicers and directors, officers, or employees of real estate agents, title insurance producers and underwriters, lenders, mortgage servicers, and examining attorneys shall not have additional liability for failure to identify a buyer as a foreign adversary or person connected with a foreign adversary.

(3) Make technical changes.

Representative Gregory Miller offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 9 yeas, 0 nays, and 1 abstention. Representatives Amedee, Boyd, Echols, Emerson, Frieman, Hodges, Mike Johnson, Knox, and Nelson voted yea. Representative Gregory Miller abstained.

Representative Gregory Miller abstained.

House Bill No. 259 by Representative Marcelle

On behalf of Representative Marcelle, Representative Gregory Miller offered a motion to voluntarily defer action on House Bill No. 259, a constitutional amendment, which creates an exception to maximum one-year period for appropriations for nongovernmental entities. Without objection, action on House Bill No. 259 was voluntarily deferred by a vote of 12 yeas, 0 nays, and 1 abstention. Representatives Amedee, Boyd, Echols, Emerson, Frieman, Garofalo, Hodges, Jefferson, Mike Johnson, Knox, Muscarello, and Seabaugh voted yea. Representative Gregory Miller abstained.
