#### III. DISCUSSION OF LEGISLATION

## **House Bill No. 615 by Representative Hodges**

Representative Davis announced that action on House Bill No. 615, which assesses fees on remittances of money to foreign countries and dedicates fee proceeds to salary increases for teachers and to costs of English as a second language programs in public schools, was voluntarily deferred.

# House Concurrent Resolution No. 59 by Representative Beaullieu

Representative Beaullieu presented House Concurrent Resolution No. 59, which requests the U.S. Securities and Exchange Commission to withdraw its proposed rule with respect to climate-related disclosures for investors.

Representative Davis offered amendments to make technical changes. Representative Davis offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 10 yeas and 0 nays. Representatives Davis, Brown, Goudeau, Jordan, McKnight, Newell, Pressly, St. Blanc, Tarver, and Thomas voted yea.

Without objection, action on House Bill No. 546 was voluntarily deferred by a vote of 11 yeas and 0 nays. Representatives Brown, Goudeau, Hilferty, Jordan, LeFleur, McKnight, Newell, Pressly, St. Blanc, Tarver, and Thomas voted yea.

## **House Bill No. 333 by Representative Pressly**

### **House Bill No. 606 by Representative Jordan**

Representative Jordan presented House Bill No. 606, which provides relative to safe housing.

Representative Thomas offered amendments to make technical changes. Representative Thomas offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 9 yeas and 0 nays. Representatives Brown, Hilferty, Jordan, LeFleur, McKnight, Newell, St. Blanc, Tarver, and Thomas voted yea.

Representative Jordan offered amendments to:

(1) Replace proposed law and state that a lessee may choose to terminate his lease if, after the execution of a lease, two or more violent crimes or drug offenses with official police reports occur one-tenth of a mile radius of the property.

(2) Make technical changes.

Representative Jordan offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 10 yeas and 0 nays. Representatives Brown, Hilferty, Jordan, LeFleur, McKnight, Newell, Pressly, St. Blanc, Tarver, and Thomas voted yea.

Representative Wright presented House Concurrent Resolution No. 15, which expresses recognition and encouragement of the economic ties and friendship between the state of Louisiana and the Republic of China.

Representative Brown offered a motion to report House Concurrent Resolution No. 15 favorably. Without objection, House Concurrent Resolution No. 15 was reported favorably by a vote of 9 yeas and 0 nays. Representatives Davis, Brown, Goudeau, Hilferty, LaFleur, Newell, St. Blanc, Tarver, and Thomas voted yea.

# House Bill No. 180 by Representative Willard

Representative Willard presented House Bill No. 180, which provides relative to housing opportunities.

Representative Hilferty offered amendments to make technical changes. Representative Hilferty offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 9 yeas and 0 nays. Representatives Davis, Brown, Goudeau, Hilferty, LaFleur, Newell, St. Blanc, Tarver, and Thomas voted yea.

Representative Newell offered amendments that would have clarified the required disclosures to be made by a housing provider, allowed a housing provider to manage by electronic means any information required by a proposed law, and prohibited liability or immunity on behalf of a housing provider under certain circumstances. Representative Newell offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 10 yeas and 0 nays. Representatives Goudeau, Hilferty, Jordan, LaFleur, McKnight, Newell, Pressly, St. Blanc, Tarver, and Thomas voted yea.
