### III. DISCUSSION OF LEGISLATION

## **House Bill No. 41 by Representative Frieman**

Representative Frieman presented House Bill No. 41, which provides relative to health coverage plan benefits for occupational therapy services delivered via telehealth.

Representative Davis presented House Bill No. 186, which provides relative to health insurance coverage for standard fertility preservation services.
