Minutes of Meeting 2023 Regular Session May 18, 2023

I. CALL TO ORDER

Representative Rick Edmonds, chairman of the House Committee on Municipal, Parochial and Cultural Affairs, called the meeting to order at 9:30 a.m. in Room 6, in the state capitol in Baton Rouge, Louisiana.

III. DISCUSSION OF LEGISLATION

Representative Edmonds offered a motion to limit presenters and witness testimony to three minutes. Without objection, the motion was adopted by a vote of 11 yeas and 0 nays. Representatives Edmonds, DuBuisson, Farnum, Fontenot, Freiberg, Glover, Lyons, McKnight, Newell, Schamerhorn, and Willard voted yea.

Senate Bill No. 92 by Senator Fesi

Senator Fesi presented Senate Bill No. 92, which provides for the board of commissioners of veterans' memorial districts, and provided a brochure of the Regional Military Museum in Houma, labeled Exhibit A, which is included in the committee records.

Representative Freiberg offered a motion to report Senate Bill No. 92 favorably. Without objection, Senate Bill No. 92 was reported favorably by a vote of 9 yeas and 0 nays. Representatives Edmonds, DuBuisson, Farnum, Fontenot, Freiberg, Kerner, Marcelle, McKnight, and Schamerhorn voted yea.

House Concurrent Resolution No. 91 by Representative Boyd

Representative Boyd presented House Concurrent Resolution No. 91, which urges the New Orleans Recreation Development Commission to have automated external defibrillators on its premises.

Representative Farnum offered a motion to report House Concurrent Resolution No. 91 favorably. Without objection, House Concurrent Resolution No. 91 was reported favorably by a vote of 9 yeas and 0 nays. Representatives Edmonds, DuBuisson, Farnum, Fontenot, Freiberg, Kerner, Marcelle, McKnight, and Schamerhorn voted yea.

Senate Bill No. 37 by Senator Allain

Senator Allain presented Senate Bill No. 37, which provides relative to the civil service status of employees of the Berwick Housing Authority.

Representative Farnum offered a motion to report Senate Bill No. 37 favorably. Without objection, Senate Bill No. 37 was reported favorably by a vote of 9 yeas and 0 nays. Representatives Edmonds, DuBuisson, Farnum, Fontenot, Freiberg, Kerner, Marcelle, McKnight, and Schamerhorn voted yea.

Senate Bill No. 222 by Senator Allain

Senator Allain presented Senate Bill No. 222, which provides relative to the civil service status of employees of the Morgan City Housing Authority.

Representative Freiberg offered a motion to report Senate Bill No. 222 favorably. Without objection, Senate Bill No. 222 was reported favorably by a vote of 9 yeas and 0 nays. Representatives Edmonds, DuBuisson, Farnum, Fontenot, Freiberg, Kerner, Marcelle, McKnight, and Schamerhorn voted yea.

Senate Bill No. 57 by Senator Foil

Senator Foil presented Senate Bill No. 57, which provides for the board of commissioners for the East Baton Rouge Parish Communications District.

Representative Freiberg offered a motion to report Senate Bill No. 57 favorably. Without objection, Senate Bill No. 57 was reported favorably by a vote of 10 yeas and 0 nays. Representatives Edmonds, DuBuisson, Farnum, Fontenot, Freiberg, Kerner, Lyons, Marcelle, McKnight, and Schamerhorn voted yea.

Senate Bill No. 70 by Senator Fields

Senator Fields presented Senate Bill No. 70, which authorizes the creation of cooperative economic development districts affiliated with Southern University and Louisiana State University in East Baton Rouge Parish.

Representative Edmonds offered amendments to remove provisions that prohibited the district from levying taxes, assessments, or fees on property operated for industrial use and instead prohibit the district from levying or assessing any property tax fee on property that is operated as an exempt entity; remove the reference to industrial uses and instead provide a definition of "industrial activities"; and define "exempt entity".

Representative Edmonds offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 11 yeas and 0 nays. Representatives Edmonds,

DuBuisson, Farnum, Fontenot, Freiberg, Kerner, Lyons, Marcelle, McKnight, Schamerhorn, and Willard voted yea.

Representative Fontenot offered amendments to require the district to hold any election regarding the levy of taxes or assessments on a date provided for in present law relative to gubernatorial or congressional primary elections (R.S. 18:402(A)(1) or (B)(1)).

Representative Fontenot offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 11 yeas and 0 nays. Representatives Edmonds, DuBuisson, Farnum, Fontenot, Freiberg, Kerner, Lyons, Marcelle, McKnight, Schamerhorn, and Willard voted yea.

Representative Marcelle offered a motion to report Senate Bill No. 70 with amendments. Without objection, Senate Bill No. 70 was reported with amendments by a vote of 11 yeas and 0 nays. Representatives Edmonds, DuBuisson, Farnum, Fontenot, Freiberg, Kerner, Lyons, Marcelle, McKnight, Schamerhorn, and Willard voted yea.

Witness cards submitted by individuals who did not speak are as follows: 1 in support, 1 in opposition, and 1 for information only. Witness cards are included in the committee records.

Senate Bill No. 76 by Senator Fred Mills

Senator Fred Mills presented Senate Bill No. 76, which creates a special medical district in St. Martin Parish.

Representative Fontenot offered amendments to require that any election pursuant to proposed law be held on a date that corresponds with an election date provided by present law (R.S. 18:402(A)(1) or (B)(1)) regarding gubernatorial or congressional elections.

Representative Fontenot offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 11 yeas and 0 nays. Representatives Edmonds, DuBuisson, Farnum, Fontenot, Freiberg, Kerner, Lyons, Marcelle, McKnight, Schamerhorn, and Willard voted yea.

Representative Freiberg offered a motion to report Senate Bill No. 76 favorably. Without objection, Senate Bill No. 76 was reported favorably by a vote of 10 yeas and 0 nays. Representatives Edmonds, DuBuisson, Farnum, Fontenot, Freiberg, Kerner, Lyons, McKnight, Schamerhorn, and Willard voted yea.

Senate Bill No. 58 by Senator Connick

Senator Connick presented Senate Bill No. 58, which provides for creation of a public benefit corporation in Jefferson Parish.

Representative Kerner offered a motion to report Senate Bill No. 58 favorably. Without objection, Senate Bill No. 58 was reported favorably by a vote of 9 yeas and 0 nays. Representatives Edmonds, DuBuisson, Farnum, Fontenot, Freiberg, Kerner, Lyons, Schamerhorn, and Willard voted yea.

Senate Bill No. 225 by Senator Pope

Senator Pope presented Senate Bill No. 225, which authorizes the city of Denham Springs to levy a hotel occupancy tax.

Representative Fontenot offered amendments to require that any election regarding the levy of the tax be held on a date that corresponds with an election date provided by present law (R.S. 18:402(A)(1) or (B)(1)) regarding gubernatorial or congressional primary elections.

Representative Fontenot offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 12 yeas and 0 nays. Representatives Edmonds, DuBuisson, Farnum, Fontenot, Freiberg, Kerner, Lyons, Marcelle, McKnight, Newell, Schamerhorn, and Willard voted yea.

Representative Buddy Mincey, Jr., House District No. 71, spoke in support of Senate Bill No. 225.

The administrative assistant called the roll, and Senate Bill No. 225 was reported with amendments by a vote of 11 yeas and 1 nays. Representatives DuBuisson, Farnum, Fontenot, Freiberg, Glover, Kerner, Lyons, Marcelle, McKnight, Newell, and Willard voted yea. Representative Schamerhorn voted nay.

Senate Bill No. 87 by Senator Robert Mills

Senator Robert Mills presented Senate Bill No. 87, which provides for the jurisdictional boundaries of the Benton Metropolitan Planning Commission, and provided a map of the jurisdictional boundaries of the Benton Metropolitan Planning Commission, labeled Exhibit B, which is included in the committee records.

Representative Glover offered a motion to report Senate Bill No. 87 favorably. Without objection, Senate Bill No. 87 was reported favorably by a vote of 10 yeas and 0 nays. Representatives DuBuisson, Farnum, Fontenot, Freiberg, Glover, Lyons, McKnight, Newell, Schamerhorn, and Willard voted yea.

Representative McKnight offered a motion to voluntarily defer action on Senate Bill No. 136. Without objection, action on Senate Bill No. 136 was voluntarily deferred by a vote of 9 yeas and 0 nays. Representatives DuBuisson, Farnum, Freiberg, Glover, Lyons, McKnight, Newell, Schamerhorn, and Willard voted yea.

Senate Bill No. 231 by Senator Barrow

Senator Barrow presented Senate Bill No. 231, which provides relative to the creation of the Mickens Place Crime Prevention and Improvement District in East Baton Rouge Parish.

Representative Edmonds offered amendments to change the name of the district.

Representative Edmonds offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 10 yeas and 0 nays. Representatives Edmonds, DuBuisson, Farnum, Freiberg, Glover, Lyons, McKnight, Newell, Schamerhorn, and Willard voted yea.

Representatives Edmonds, DuBuisson, Farnum, Fontenot, Freiberg, Glover, Lyons, McKnight, Newell, Schamerhorn, and Willard voted yea.
