#### III. DISCUSSION OF LEGISLATION

### House Bill No. 28 by Representative Carrier

Representative Carrier and Representative Romero presented House Bill No. 28, which designates a portion of Louisiana Highway 383 in Jefferson Davis Parish as the "Sergeant Major William Arlen Marcantel Memorial Highway".

Representative Wright offered amendments to designate a portion of Louisiana Highway 674 in Iberia Parish from Louisiana Highway 3212 to Highway 85 Patout Road as the "Veterans Memorial Highway". Representative Wright offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 13 yeas and 0 nays. Representatives Wright, Brass, Edmonston, Firment, Freiberg, Gadberry, Horton, Larvadain, Moore, Charles Owen, Robert Owen, Pierre, and Schamerhorn voted yea.

Representative Wright offered an amendment originated in committee to redesignate a portion of Interstate 49 in St. Landry Parish as the "Hannah Lee Vincent Memorial Highway". Representative Wright offered a motion to adopt the proposed amendment. Without objection, the amendment was adopted by a vote of 13 yeas and 0 nays. Representatives Wright, Brass, Edmonston, Firment, Freiberg, Gadberry, Horton, Larvadain, Moore, Charles Owen, Robert Owen, Pierre, and Schamerhorn voted yea.

Representative Freiberg offered a motion to report House Bill No. 28 with amendments. Without objection, House Bill No. 28 was reported with amendments by a vote of 13 yeas and 0 nays. Representatives Wright, Brass, Edmonston, Firment, Freiberg, Gadberry, Horton, Larvadain, Moore, Charles Owen, Robert Owen, Pierre, and Schamerhorn voted yea.

# **House Bill No. 18 by Representative Tarver**

Representative Tarver presented House Bill No. 18, which designates a certain portion of Louisiana Highway 384 in Calcasieu Parish as the "Captain Brian Bourgeois Memorial Traffic Circle".

Representative Wright offered amendments to:

(1) Add a highway designation naming a portion of La. Hwy. 40 in Folsom, Louisiana, as the "Deputy Hilery Mayo Memorial Highway".

# (2) Make technical changes.

Representative Wright offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 13 yeas and 0 nays. Representatives Wright, Brass, Edmonston, Firment, Freiberg, Gadberry, Horton, Larvadain, Moore, Charles Owen, Robert Owen, Pierre, and Schamerhorn voted yea.

Representative Edmonston offered a motion to report House Bill No. 18 with amendments. Without objection, House Bill No. 18 was reported with amendments by a vote of 13 yeas and 0 nays. Representatives Wright, Brass, Edmonston, Firment, Freiberg, Gadberry, Horton, Larvadain, Moore, Charles Owen, Robert Owen, Pierre, and Schamerhorn voted yea.

### **House Bill No. 80** by Representative Gadberry

Chairman Wright announced that action on House Bill No. 80, which provides relative to the prior approval process available to potential suppliers, was voluntarily deferred.

### House Bill No. 13 by Representative Muscarello

On behalf of Representative Muscarello, Representative Wright presented House Bill No. 13, which changes the name of one member on the South Tangipahoa Parish Port Commission.

Representative Freiberg offered a motion to report House Bill No. 13 favorably. Without objection, House Bill No. 13 was reported favorably by a vote of 13 yeas and 0 nays. Representatives Wright, Brass, Edmonston, Firment, Freiberg, Gadberry, Horton, Larvadain, Moore, Charles Owen, Robert Owen, Pierre, and Schamerhorn voted yea.

## **House Bill No. 11 by Representative Gadberry**

Representative Gadberry presented House Bill No. 11, which provides for contract limits for projects.

# **House Bill No. 73 by Representative DuBuisson**

Representative Wright offered amendments to change the bridge designation from the "Robert E. Myers, Jr. Memorial Bridge" to the "Robert E. Mayers, Jr. Memorial Bridge". Representative Wright offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 13 yeas and 0 nays. Representatives Wright, Brass, Cormier, Edmonston, Firment, Freiberg, Gadberry, Glover, Horton, Moore, Robert Owen, Pierre, and Schamerhorn voted yea.

Representative Edmonston offered a motion to report House Bill No. 50 with amendments. Without objection, House Bill No. 50 was reported with amendments by a vote of 14 yeas and 0 nays. Representatives Wright, Brass, Cormier, Edmonston, Firment, Freiberg, Gadberry, Glover, Horton, Larvadain, Moore, Robert Owen, Pierre, and Schamerhorn voted yea.
