Minutes of Meeting 2023 Regular Session April 24, 2023

I. CALL TO ORDER

Representative Stuart J. Bishop, chairman of the House Committee on Ways and Means, called the meeting to order at 9:02 a.m. in Room 6, in the state capitol in Baton Rouge, Louisiana.

III. DISCUSSION OF LEGISLATION

House Bill No. 62 by Representative Bacala

Representative Bacala presented House Bill No. 62, which reduces the rate of the state sales and use tax.

Representative DeVillier offered a motion to report House Bill No. 62 favorably, to which Representative Magee objected. The administrative assistant called the roll, and House Bill No. 62 was reported favorably by a vote of 9 yeas and 4 nays. Representatives Bishop, Beaullieu, Bourriaque, DeVillier, Farnum, Mincey, Orgeron, Schlegel, and White voted yea. Representatives Bryant, Landry, Magee, and Willard voted nay.

House Bill No. 249 by Representative Turner

Representative Turner presented House Bill No. 249, which exempts prescription drugs and insulin from local sales and use taxes.

House Bill No. 107 by Representative Turner

On behalf of Representative Turner, Representative Bishop offered a motion to voluntarily defer action on House Bill No. 107, which provides for a local sales and use tax exemption for the procurement or administration of certain prescription drugs. Without objection, action on House Bill No. 107 was voluntarily deferred by a vote of 13 yeas and 0 nays. Representatives Bishop, Beaullieu, Bourriaque, Bryant, DeVillier, Farnum, Landry, Magee, Mincey, Orgeron, Schlegel, White, and Willard voted yea.

House Bill No. 502 by Representative McFarland

On behalf of Representative McFarland, Representative Bishop offered a motion to voluntarily defer action on House Bill No. 502, which modifies the definition of the term commercial farmer by removing certain reporting requirements. Without objection, action on House Bill No. 502 was voluntarily deferred by a vote of 13 yeas and 0 nays. Representatives Bishop, Beaullieu, Bourriaque, Bryant, DeVillier, Farnum, Landry, Magee, Mincey, Orgeron, Schlegel, White, and Willard voted yea.

House Bill No. 562 by Representative Schexnayder

Representative Schexnayder presented House Bill No. 562, which provides relative to the Motion Picture Production Tax Credit.

Representative Bishop offered amendments which: (1) expand the definition of a "Louisiana promotional graphic"; (2) remove provision that would have eliminated the alternative marketing option for productions submitting an application on or after July 1, 2023; (3) remove provision that would have eliminated the \$150M Dept. of Economic Development program issuance cap; (4) add provision that specifies that the 20% allotment of the \$150M Dept. of Economic Development

program issuance cap in present law reserved for qualified entertainment companies (QEC), La. screenplay productions, and independent film productions shall not apply to state-certified productions and QEC applications submitted on or after July 1, 2023; and (5) delete the repeal of the sunset provision of this tax credit in favor of extending the sunset from July 1, 2025, to July 1, 2035.

Representative Bishop offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 14 yeas and 0 nays. Representatives Bishop, Beaullieu, Bourriaque, Bryant, DeVillier, Farnum, LaCombe, Landry, Magee, Mincey, Orgeron, Schlegel, White, and Willard voted yea.

House Bill No. 436 by Representative Travis Johnson

Representative Travis Johnson presented House Bill No. 436, which provides a state sales tax exemption for certain farmers for acquisition of renewable energy systems and items and services for energy efficiency improvements.

Representative Bishop offered amendments to terminate the tax exemption provided for in proposed law on January 1, 2026. Representative Bishop offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 11 yeas and 0 nays. Representatives Bishop, Beaullieu, Bourriaque, Bryant, DeVillier, Farnum, LaCombe, Mincey, Orgeron, White, and Willard voted yea.

Representative Mincey offered amendments to specify the paragraph of law within R.S. 47:301 in which the term "commercial farmer" is defined for purposes of proposed law. Representative Mincey offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 14 yeas and 0 nays. Representatives Bishop, Beaullieu, Bourriaque, Bryant, DeVillier, Farnum, LaCombe, Landry, Magee, McMahen, Mincey, Orgeron, White, and Willard voted yea.

Representative Bishop offered a motion to voluntarily defer action on House Bill No. 436. Without objection, action on House Bill No. 436 was voluntarily deferred by a vote of 14 yeas and 0 nays. Representatives Bishop, Beaullieu, Bourriaque, Bryant, DeVillier, Farnum, LaCombe, Landry, Magee, McMahen, Mincey, Orgeron, White, and Willard voted yea.

House Bill No. 157 by Representative DeVillier

Representative DeVillier presented House Bill No. 157, which exempts certain business utilities from a state sales and use tax levy.

Representative DeVillier offered a motion to voluntarily defer action on House Bill No. 157. Without objection, action on House Bill No. 157 was voluntarily deferred by a vote of 14 yeas and 0 nays. Representatives Bishop, Beaullieu, Bourriaque, Bryant, DeVillier, Farnum, LaCombe, Landry, Magee, McMahen, Mincey, Orgeron, White, and Willard voted yea.

House Bill No. 203 by Representative DeVillier

Representative DeVillier presented House Bill No. 203, a constitutional amendment which provides relative to state sales and use tax exemptions for food for home consumption, residential utilities, and prescription drugs.

Representative DeVillier offered a motion to voluntarily defer action on House Bill No. 203. Without objection, action on House Bill No. 203 was voluntarily deferred by a vote of 14 yeas and 0 nays. Representatives Bishop, Beaullieu, Bourriaque, Bryant, DeVillier, Farnum, LaCombe, Landry, Magee, McMahen, Mincey, Orgeron, White, and Willard voted yea.

Representative DeVillier presented House Bill No. 204, which provides relative to the state sales and use tax exemptions for food for home consumption, residential utilities, and prescription drugs.

Representative DeVillier offered a motion to voluntarily defer action on House Bill No. 204. Without objection, action on House Bill No. 204 was voluntarily deferred by a vote of 13 yeas and 0 nays. Representatives Bishop, Beaullieu, Bourriaque, Bryant, DeVillier, Farnum, LaCombe, Landry, McMahen, Mincey, Orgeron, White, and Willard voted yea.

House Bill No. 161 by Representative Kerner

Representative Kerner presented House Bill No. 161, which changes local sales and use tax exemptions for commercial fishermen and certain seafood processing facilities from optional to mandatory.

Representative Bourriaque offered a motion to report House Bill No. 161 favorably. Without objection, House Bill No. 161 was reported favorably by a vote of 12 yeas and 0 nays.

Representatives Bishop, Beaullieu, Bourriaque, Bryant, DeVillier, Farnum, LaCombe, Landry, McMahen, Orgeron, White, and Willard voted yea.

House Bill No. 171 by Representative Beaullieu

Representative Beaullieu presented House Bill No. 171, which provides relative to the requirement for marketplace facilitators to collect and remit sales and use taxes.

Representative Beaullieu offered a motion to report House Bill No. 171 favorably. Without objection, House Bill No. 171 was reported favorably by a vote of 12 yeas and 0 nays. Representatives Bishop, Beaullieu, Bourriaque, Bryant, DeVillier, Farnum, LaCombe, Landry, McMahen, Mincey, Orgeron, and White voted yea.

House Bill No. 558 by Representative Beaullieu

Representative Beaullieu presented House Bill No. 558, which provides for the collection and remittance of state and local sales and use taxes.

Mr. Drew Talbot, attorney, Louisiana Association of Tax Administrators (LATA), 8480 Bluebonnet Boulevard, Suite D, Baton Rouge, Louisiana 70810, spoke in support of House Bill No. 558.

Representative Beaullieu offered amendments which: (1) prohibit the tax, interest, or penalty rates in a taxing jurisdiction, from being changed unless the change is effective on the first day of Jan., April, July, or Oct., and the board and advisory committee have been notified in advance. Requires a taxing authority to notify the single collector for the parish of the date a change in a tax, interest, or penalty rate becomes effective; (2) authorize the failure or refusal of a taxing authority to provide timely notice of a rate change to the single collector for a parish to be an absolute defense against a claim by a taxing authority against the single tax collector for the parish; (3) define a "tax rate change" for purposes of proposed law; (4) remove present law requirement that the chair of the board also serve as chair of the committee; (5) remove attorney fees from the list of information excepted in present law from information that must be uniform on sales tax returns for all taxing authorities; (6) require each collector to provide certain requested information to the board and the committee rather than the secretary of DOR and the committee and extend the requirement for submission of information necessary to maintain the uniform electronic local return and remittance system; (7) authorize failure or refusal of a collector to provide requested information to the board

Representatives Bishop, Beaullieu, Bourriaque, Bryant, DeVillier, Farnum, LaCombe, Landry, McMahen, Mincey, White, and Willard voted yea.

House Bill No. 256 by Representative Gregory Miller

Representative Gregory Miller presented House Bill No. 256, which requires extension of the deadline to pay local sales taxes when the deadline for payment of the tax falls on certain holidays.

Representative Bishop offered a motion to report House Bill No. 256 favorably. Without objection, House Bill No. 256 was reported favorably by a vote of 12 yeas and 0 nays. Representatives Bishop, Beaullieu, Bourriaque, Bryant, DeVillier, Farnum, LaCombe, Landry, McMahen, Mincey, Orgeron, and White voted yea.

House Bill No. 621 by Representative Cormier

Representative Cormier presented House Bill No. 621, which levies a tax on tickets for admission to certain college football games and dedicates the avails of the tax to passenger rail service between New Orleans and Baton Rouge.

Representatives Bishop, Beaullieu, Bourriaque, DeVillier, Farnum, LaCombe, Magee, McMahen, Mincey, Schlegel, and White voted nay.

Representative Bishop offered a motion to involuntarily defer action on House Bill No. 621. Without objection, action on House Bill No. 621 was involuntarily deferred by a vote of 15 yeas and 0 nays. Representatives Bishop, Beaullieu, Bourriaque, Bryant, DeVillier, Farnum, LaCombe, Landry, Magee, McMahen, Mincey, Orgeron, Schlegel, White, and Willard voted yea.
