Representative Illg offered a motion to approve the plan for security personnel, including pay structure as presented by the Capitol Security director and to authorize the speaker of the House and Senate president to work with the Capitol Security director to give final approval of the plan for security personnel as needed. Without objection, the motion passed by a vote of 8 yeas and 0 nays. Representatives Bacala, DeVillier, Boyer, Illg, and Willard voted yea. Senators Miguez, Cloud, and Stine voted yea.

Representative Illg offered a motion to approve the plan for upgrades to physical security and technology within the state capitol as presented by the Capitol Security director, subject to final approval by the speaker of the House and Senate president. Without objection, the motion passed by a vote of 8 yeas and 0 nays. Representatives Bacala, DeVillier, Boyer, Illg, and Willard voted yea. Senators Miguez, Cloud, and Stine voted yea.
