#### III. DISCUSSION OF LEGISLATION

# Senate Bill No. 9 by Senator Bass

Senator Bass presented Senate Bill No. 9, which adds federal and state military installations and facilities to the locations over which the use of an unmanned aircraft system is prohibited.

Representative Horton offered a motion to report Senate Bill No. 9 favorably. Without objection, Senate Bill No. 9 was reported favorably by a vote of 9 yeas and 0 nays. Representatives Villio, Adams, Bacala, Boyer, Cox, Horton, Knox, Moore, and Wiley voted yea.

## House Bill No. 103 by Representative Gadberry

Representative Gadberry presented House Bill No. 103, which creates the crime of indecent visual depiction of a minor.

Without objection, action on House Bill No. 103 was voluntarily deferred by a vote of 7 yeas and 0 nays. Representatives Villio, Adams, Boyer, Cox, LaFleur, Moore, and Wiley voted yea.

# **House Bill No. 261 by Representative Galle**

Representative Galle presented House Bill No. 261, which provides relative to unlawful use of an unmanned aircraft system.

Representative Villio offered amendments to make technical changes, to add the crime of unlawful use of an unmanned aircraft system at a parade, and to provide for elements, definitions, penalties, and exceptions to the crime. Representative Villio offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 8 yeas and 0 nays. Representatives Villio, Adams, Boyer, Cox, Knox, LaFleur, Moore, and Wiley voted yea.

Representative Henry presented House Bill No. 93, which provides relative to the authority of the Acadiana Regional Juvenile Justice District to levy certain taxes.

Representative Wiley offered a motion to report House Bill No. 93 favorably. Without objection, House Bill No. 93 was reported favorably by a vote of 9 yeas and 0 nays. Representatives Villio, Bacala, Boyer, Cox, Horton, Knox, LaFleur, Moore, and Wiley voted yea.

# House Bill No. 268 by Representative LaFleur

Representative LaFleur presented House Bill No. 268, which amends terminology regarding pornography involving juveniles.

Without objection, the amendment was adopted by a vote of 9 yeas and 0 nays. Representatives Villio, Adams, Bacala, Boyer, Cox, Horton, Knox, LaFleur, and Moore voted yea.

Representative LaFleur offered a motion to report House Bill No. 268 with amendments. Without objection, House Bill No. 268 was reported with amendments by a vote of 9 yeas and 0 nays. Representatives Villio, Adams, Bacala, Boyer, Cox, Horton, Knox, LaFleur, and Moore voted yea.

## House Bill No. 163 by Representative Dickerson

Representative Dickerson presented House Bill No. 163, which provides relative to victims of certain sex-related crimes.

On behalf of the author, Representative Villio offered amendments to:

- (1) Make technical changes.
- (2) Specify that the mandatory assessment of \$2,000 applies to a person who is convicted of or pleads guilty or nolo contendere to the present law offense of pandering that involves the prostitution of persons under the age of eighteen years or fourteen years, rather than pandering in general.
- (3) Clarify that the \$2,000 that is assessed for certain sex offenses shall not alter the dispositions of fines and forfeitures ordered by the court under present law (R.S. 15:571.11).

(4) Restore provisions of present law relative to the distribution of fines related to convictions for solicitation of prostitutes and purchase of commercial sexual activity.

Representative Villio offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 9 yeas and 0 nays. Representatives Villio, Adams, Bacala, Cox, Horton, Knox, LaFleur, Moore, and Wiley voted yea.

Monica Taylor, Governor's Office for Human Trafficking Prevention, no address provided, spoke for information only on House Bill No. 163.

Representative LaFleur offered a motion to report House Bill No. 163 with amendments. Without objection, House Bill No. 163 was reported with amendments by a vote of 10 yeas and 0 nays. Representatives Villio, Adams, Bacala, Boyer, Cox, Horton, Knox, LaFleur, Moore, and Wiley voted yea.

Representative Mack presented House Bill No. 15, which adds certain substances to the Uniform Controlled Dangerous Substances Law.

# **House Bill No. 151 by Representative Cox**

Representative Cox presented House Bill No. 151, which provides with respect to the issuance of non-gaming supplier permits.

Representative Cox offered amendments to specify that gaming operators are subject to the jurisdiction of the Louisiana Gaming Control Board and to add that a gaming operator who is found

unsuitable may be required to reimburse the board and division for reasonable costs up to \$250. Representative Cox offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 8 yeas and 0 nays. Representatives Villio, Adams, Bacala, Boyer, Cox, Horton, Moore, and Wiley voted yea.

Wade Duty, Louisiana Casino Association, P.O. Box 3801, Baton Rouge, LA 70821, spoke in support of House Bill No. 151.

Representative Cox offered a motion to report House Bill No. 151 with amendments. Without objection, House Bill No. 151 was reported with amendments by a vote of 10 yeas and 0 nays. Representatives Villio, Adams, Bacala, Boyer, Cox, Horton, Knox, LaFleur, Moore, and Wiley voted yea.

# House Bill No. 76 by Representative Moore

Representative Moore presented House Bill No. 76, which creates the crimes of felony and misdemeanor intentional exposure to a sexually transmitted disease.

Representative Moore offered amendments to:

- (1) Make technical changes.
- (2) Clarify that proposed law applies to incurable sexually transmitted diseases.
- (3) Clarify that the state of mind for this crime is when the conduct is committed knowingly and intentionally.
- (4) Add, as an element of proposed law, exposure of an STD through any means or contact if the infected person knew he had an incurable sexually transmitted disease at the time of the exposure and the victim had not given consent.
- (5) Clarify that certain penalties of proposed law apply when the victim, rather than the offender, has been diagnosed with an intellectual disability.

- (6) Remove the burden of proof for asserting an affirmative defense relative to the knowledge of the person exposed to the sexually transmitted disease.
- (7) Remove proposed law provisions relative to lifetime supervision of the offender upon release from imprisonment.
- (8) Designate the felony violation of proposed law as a sex offense.

Representative Moore offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 10 yeas and 0 nays. Representatives Villio, Adams, Bacala, Boyer, Cox, Horton, Knox, LaFleur, Moore, and Wiley voted yea.
