III. DISCUSSION OF LEGISLATION

House Bill No. 343 by Representative Davis

Representative Davis presented House Bill No. 343, which provides relative to condominium associations.

Representative Carlson offered a motion to report House Bill No. 343 favorably. Without objection, House Bill No. 343 was reported favorably by a vote of 11 yeas and 0 nays. Representatives Muscarello, Brown, Carlson, Wilford Carter, Chenevert, Edmonston, Egan, Mike Johnson, Melerine, Taylor, and Turner voted yea.

Senate Bill No. 35 by Senator Price

Senator Price presented Senate Bill No. 35, which provides for legal servitudes.

Representative Brown offered a motion to report Senate Bill No. 35 favorably. Without objection, Senate Bill No. 35 was reported favorably by a vote of 11 yeas and 0 nays. Representatives Muscarello, Brown, Carlson, Wilford Carter, Chenevert, Edmonston, Egan, Mike Johnson, Melerine, Taylor, and Turner voted yea.

House Bill No. 197 by Representative Mike Johnson

Representative Mike Johnson offered a motion to voluntarily defer action on House Bill No. 197, which expands the application of medical malpractice to include physical therapist assistants and occupational therapist assistants. Without objection, action on House Bill No. 197 was voluntarily deferred by a vote of 11 yeas and 0 nays. Representatives Muscarello, Brown, Carlson, Wilford Carter, Chenevert, Edmonston, Egan, Mike Johnson, Melerine, Taylor, and Turner voted yea.

House Bill No. 74 by Representative Mike Johnson

Representative Mike Johnson presented House Bill No. 74, which provides for the termination of manufacturer vehicle tracking services in certain cases of domestic abuse, sexual assault, or stalking.

Representative Mike Johnson offered amendments to:

- (1) Make technical changes
- (2) Change the name of the fund from "Christine Dowdall Fund" to "Survivor Empowerment Fund".
- (3) Provide that proposed law shall not apply to a motor vehicle manufacturer that technologically is unable to disable the remote access technology on a motor vehicle.
- (4) Provide that a motor vehicle manufacturer and any officer, director, employee, vendor, or agent thereof shall not be subject to liability for any claims deriving from the motor vehicle manufacturer's technological inability to disable the remote access technology.

Representative Mike Johnson offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 11 yeas and 0 nays. Representatives Muscarello, Brown, Carlson, Wilford Carter, Chenevert, Edmonston, Egan, Mike Johnson, Melerine, Taylor, and Turner voted yea.

Senate Bill No. 49 by Senator Miller

Representative Brown offered a motion to report Senate Bill No. 49 favorably. Without objection, Senate Bill No. 49 was reported favorably by a vote of 11 yeas and 0 nays. Representatives Muscarello, Brown, Carlson, Wilford Carter, Chenevert, Edmonston, Egan, Melerine, Taylor, Turner, and Wyble voted yea.

House Bill No. 575 by Representative Ventrella

Representative Ventrella presented House Bill No. 575, which provides relative to liability for the unlawful termination of a pregnancy.

- (3) Add an exemption to liability for any mental health professional or advocate in certain circumstances.

Representative Ventrella offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 13 yeas and 0 nays. Representatives Muscarello, Brown, Carlson, Wilford Carter, Chenevert, Edmonston, Egan, Glorioso, Melerine, Taylor, Turner, Ventrella, and Wyble voted yea.

Representatives Carlson, Edmonston, Egan, Glorioso, Melerine, Turner, Ventrella, and Wyble voted yea. Representatives Wilford Carter and Taylor voted nay. Representative Muscarello abstained.

House Bill No. 259 by Representative Taylor

Representative Taylor presented House Bill No. 259, which provides relative to bonds for notaries public.

Representative Taylor offered amendments to:

- (1) Make technical changes.
- (2) Provide for an effective date of February 1, 2026.

(3) Remove the provision in present law which provides that the provisions of proposed law shall not be applicable to notarial bonds which are currently valid and enforceable until such bonds expire and are required to be renewed.

Representative Taylor offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 9 yeas and 0 nays. Representatives Muscarello, Carlson, Wilford Carter, Edmonston, Egan, Glorioso, Taylor, Turner, and Wyble voted yea.

Representatives Muscarello, Brown, Carlson, Wilford Carter, Chenevert, Edmonston, Melerine, Taylor, Turner, and Wyble voted yea.

Senate Bill No. 93 by Senator Lambert

Representative Brown offered a motion to report Senate Bill No. 93 favorably. Without objection, Senate Bill No. 93 was reported favorably by a vote of 11 yeas and 0 nays. Representatives Muscarello, Brown, Carlson, Wilford Carter, Chenevert, Edmonston, Glorioso, Melerine, Taylor, Turner, and Wyble voted yea.

Representatives Muscarello, Carlson, Chenevert, Edmonston, Egan, Glorioso, Melerine, and Turner voted yea. Representatives Brown, Wilford Carter, Taylor, and Wyble voted nay.

Senate Bill No. 116 by Senator Kleinpeter

On behalf of Senator Kleinpeter, Representative Brown presented Senate Bill No. 116, which provides for reciprocal notarial authority of notaries qualified in St. Martin Parish and St. Landry Parish.

Representative Carlson offered a motion to report Senate Bill No. 116 favorably. Without objection, Senate Bill No. 116 was reported favorably by a vote of 10 yeas and 0 nays. Representatives Muscarello, Brown, Carlson, Wilford Carter, Edmonston, Egan, Glorioso, Melerine, Taylor, and Turner voted yea.

House Bill No. 295 by Representative Tarver

Representative Tarver presented House Bill No. 295, a constitutional amendment, which limits the amount of State General Fund (Direct) revenues that may be appropriated in a fiscal year for recurring expenses and restricts use of such revenues above that limit.

Representative Muscarello offered a motion to adopt the House Rule 6.8(A) Report to House Bill No. 295, which stated that the measure could not be accomplished statutorily and would, therefore, require a constitutional amendment. Without objection, the House Rule 6.8(A) Report to House Bill No. 295 was adopted by a vote of 10 yeas and 0 nays. Representatives Muscarello, Brown, Carlson, Wilford Carter, Edmonston, Egan, Glorioso, Melerine, Taylor, and Turner voted yea.

Representative Muscarello offered a motion to report House Bill No. 295 without amendments. Without objection, House Bill No. 295 was reported without amendments by a vote of 11 yeas and 0 nays. Representatives Muscarello, Brown, Carlson, Wilford Carter, Edmonston, Egan, Glorioso, Melerine, Taylor, Turner, and Wyble voted yea.
