## **III. DISCUSSION OF LEGISLATION**

### **House Bill No. 565 by Representative Spell**

Representative Miller offered a motion to voluntarily defer action on House Bill No. 565, which provides relative to third-party liability, claim adjudication, and timeliness of such within the state medical assistance program. Without objection, action on House Bill No. 565 was voluntarily deferred by a vote of 15 yeas and 0 nays. Representatives Miller, Butler, Chassion, Chenevert, Crews, Dickerson, Echols, Egan, Fisher, Hughes, Jackson, McMahan, Spell, Stagni, and Turner voted yea.

### **House Bill No. 115 by Representative Stagni**

Representative Stagni presented House Bill No. 115, which provides relative to the donation of source plasma.

Representative Miller presented House Bill No. 314, which modifies the regulatory authority of the Louisiana Department of Health in relation to hospital classifications.

Representative Miller offered amendments to change the effective date to January 1, 2026. Representative Miller offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 14 yeas and 0 nays. Representatives Miller, Butler, Chassion, Chenevert, Crews, Dickerson, Echols, Egan, Fisher, Hughes, Jackson, McMahan, Stagni, and Turner voted yea.

Veronica Gillispie, Louisiana Department of Health, 628 North Fourth Street, Baton Rouge, LA 70802, spoke for information only on House Bill No. 314.

Representative Hughes offered a motion to report House Bill No. 314 with amendments. Without objection, House Bill No. 314 was reported with amendments by a vote of 14 yeas and 0 nays. **House Bill No. 454 by Representative Miller**

Representative Miller presented House Bill No. 454, which requires Medicaid coverage for certain doula services.

**House Bill No. 317 by Representative Echols**

Representative Echols presented House Bill No. 317, which establishes prohibited acts by certain healthcare facility lessors and lessees.

Representative Hughes offered technical amendments. Representative Hughes offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 13 yeas and 0 nays. Representatives Miller, Chassion, Chenevert, Crews, Dickerson, Echols, Egan, Fisher, Hughes, Jackson, McMahan, Stagni, and Turner voted yea.

Representative Echols offered amendments to provide that a lessee facility means a hospital operating under a lease agreement and to provide that a lessor entity means an entity that leases a hospital to another entity. Representative Echols offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 13 yeas and 0 nays. Representatives Miller, Chassion, Chenevert, Crews, Dickerson, Echols, Egan, Fisher, Hughes, Jackson, McMahan, Stagni, and Turner voted yea.

**House Bill No. 399 by Representative Chenevert**

*Representative Miller in the chair.*

Representative Chenevert presented House Bill No. 399, which provides with respect to the profession of dietetics and dieticians.

Representative Miller offered technical amendments. Representative Miller offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 13 yeas and 0 nays. Representatives Miller, Chassion, Chenevert, Crews, Dickerson, Echols, Egan, Fisher, Hughes, Jackson, McMahan, Stagni, and Turner voted yea.

Brooke Lowenkron, Dietitians, 17443 Waterloo Drive, Baton Rouge, LA 70817, spoke in support of House Bill No. 399.

Fran Boudreax White, LA Academy of Nutrition and Dietetics, 815 Louray Drive, Baton Rouge, LA 70808, spoke in support of House Bill No. 399.

Representative Chenevert offered amendments to exempt certain records related to the compact from public records requests. Representative Chenevert offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 10 yeas and 0 nays. Representatives Miller, Chassion, Chenevert, Crews, Dickerson, Egan, Fisher, McMahan, Stagni, and Turner voted yea.

Representative Stagni offered a motion to report House Bill No. 399 with amendments. Without objection, House Bill No. 399 was reported with amendments by a vote of 10 yeas and 0 nays. Representatives Miller, Chassion, Chenevert, Crews, Dickerson, Egan, Fisher, McMahan, Stagni, and Turner voted yea.

#### **House Bill No. 456 by Representative Turner**

Representative Turner presented House Bill No. 456, which provides relative to the Local Healthcare Provider Participation Program.

Ryan Cross, Franciscan Missionaries of Our Lady Health System, 4200 Essen Lane, Baton Rouge, LA 70809, spoke in support of House Bill No. 456.

Representative Turner offered amendments to clarify that a local hospital assessment payment will be imposed on each paying hospital in the parish in accordance with federal law and to make technical changes. Representative Turner offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 10 yeas and 0 nays. Representatives Miller, Chassion, Chenevert, Crews, Dickerson, Egan, Jackson, McMahan, Stagni, and Turner voted yea.

Representative Jackson offered a motion to report House Bill No. 456 with amendments. Without objection, House Bill No. 456 was reported with amendments by a vote of 12 yeas and 0 nays. Representatives Miller, Chassion, Chenevert, Crews, Dickerson, Echols, Egan, Fisher, Jackson, McMahan, Stagni, and Turner voted yea.

**House Bill No. 544 by Representative Turner**

Representative Turner presented House Bill No. 544, which transfers powers and duties of the Nursing Supply and Demand Council and the Simulation Medical Training and Education Council to the Louisiana Health Works Commission.

Representative Miller offered technical amendments. Representative Miller offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 10 yeas and 0 nays. Representatives Miller, Chassion, Chenevert, Crews, Dickerson, Echols, Fisher, McMahan, Stagni, and Turner voted yea.

Representative Turner offered amendments to add the president of the Louisiana State Nurses Association or his designee to the executive committee of the Louisiana Health Works Commission. Representative Turner offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 10 yeas and 0 nays. Representatives Miller, Chassion, Chenevert, Crews, Dickerson, Echols, Fisher, McMahan, Stagni, and Turner voted yea.

Representative Turner offered a motion to report House Bill No. 544 with amendments. Without objection, House Bill No. 544 was reported with amendments by a vote of 10 yeas and 0 nays. Representatives Miller, Chassion, Chenevert, Crews, Dickerson, Echols, Fisher, McMahan, Stagni, and Turner voted yea.

**House Bill No. 539 by Representative Berault**

On behalf of Representative Berault, Representative Echols presented House Bill No. 539, which creates a program and fund administered by the La. Dept. of Health for the purpose of recruiting specialist physicians to practice medicine in the state.

Representative Miller offered technical amendments. Representative Miller offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 11 yeas and 0 nays. Representatives Miller, Chassion, Chenevert, Crews, Dickerson, Echols, Fisher, Jackson, McMahan, Stagni, and Turner voted yea.

Representative Berault joined Representative Echols at the table and provided closing remarks on House Bill No. 539.

Representative Stagni offered a motion to report House Bill No. 539 with amendments. Without objection, House Bill No. 539 was reported with amendments by a vote of 12 yeas and 0 nays. Representatives Miller, Berault, Chassion, Chenevert, Crews, Dickerson, Echols, Fisher, Jackson, McMahan, Stagni, and Turner voted yea.
