**III. DISCUSSION OF LEGISLATION****Senate Bill No. 14 by Senator McMath**

Senator McMath presented Senate Bill No. 14, which provides relative to nutrition.

Representative Miller offered amendments to:

- (1) Add early learning centers and aftercare to the provisions prohibiting certain foods from being served to students.
- (2) Clarify provisions related to exceptions to the prohibition of certain food ingredients for concession stands and vending machines.
- (3) Remove titanium dioxide and diacetyl tartaric and fatty acid esters of mono- and diglycerides from the list of prohibited food ingredients.
- (4) Remove synthetic and artificial vanillin and titanium dioxide from the list of ingredients that would trigger a notice statement.
- (5) Create exceptions to the notice statement requirement for certain foods.
- (6) Make technical changes.

Representative Miller offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 13 yeas and 0 nays. Representatives Miller, Berault, Chassion, Chenevert, Crews, Dickerson, Echols, Egan, Fisher, Hughes, McMahan, Stagni, and Turner voted yea.

### **House Bill No. 619 by Representative Knox**

*This is a continuation of the discussion on House Bill No. 619 from May 14, 2025. Please check for the prior action to complete the record of discussion and motions on House Bill No. 619.*

Representative Knox presented House Bill No. 619, which provides relative to group and community homes.

Representative Chassion offered amendments to:

1. Require political subdivisions to notify LDH within 10 days of designating property for public camping in accordance with procedures established by LDH.
2. Require that within 30 days after designating property for public camping, the political subdivision shall publish the minimum standards and procedures on the political subdivision's website.
3. Provide that a resident of the political subdivision residing within 1,000 feet of a public encampment not in a designated area, an owner of a business located in the political subdivision located within 1,000 feet of a public encampment not in a designated area, a nonprofit organization located within one thousand feet of a public encampment not in a designated area or the district attorney to bring a civil action in any court of competent jurisdiction against the political subdivision or applicable municipality for violation.
4. Change the 10-day requirement to a 90-day requirement to cure a violation.
5. Create the Encampment Mitigation Reimbursement Fund which establishes how monies in the fund shall be used and how monies are invested in the fund.
6. Establish the oversight of publicly-funded homeless service providers and require that any continuum of care organization or homeless service provider that receives state or local public funds shall provide certain information.

Representative Chassion offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 11 yeas and 0 nays. Representatives Miller, Berault, Chassion, Chenevert, Crews, Egan, Fisher, Jackson, McMahan, Stagni, and Turner voted yea.

### **House Bill No. 265 by Representative Mena**

Representative Mena presented House Bill No. 265, which provides with respect to prohibitions regarding the employment of ambulance drivers convicted of certain offenses.

Representative Chassion offered amendments to:

1. Remove from the list of convictions: aggravated arson, first degree robbery, extortion, identity theft where the value is between \$200 to \$1,000 and possession with intent to distribute controlled dangerous substances.
2. Require that no employer shall hire any licensed ambulance personnel or nonlicensed person when the results of a criminal history check reveal that the licensed ambulance personnel or nonlicensed person has been convicted of the felony offense involving theft, pursuant to R.S. 14:67(B)(1).
3. Make technical changes.

Representative Chassion offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 11 yeas and 0 nays. Representatives Miller, Berault, Chassion, Chenevert, Crews, Dickerson, Egan, Jackson, McMahan, Spell, and Turner voted yea.

Representative Chassion offered a motion to report House Bill No. 265 with amendments. Without objection, House Bill No. 265 was reported with amendments by a vote of 11 yeas and 0 nays. Representatives Miller, Berault, Chassion, Chenevert, Crews, Dickerson, Egan, Jackson, McMahan, Spell, and Turner voted yea.
