**III. DISCUSSION OF LEGISLATION****House Concurrent Resolution No. 54 by Representative Deshotel**

Representative Deshotel presented House Concurrent Resolution No. 54, which urges and requests the Louisiana Department of Health to review and revise its regulations regarding minimum chlorine concentration levels in public water systems. Representative Deshotel provided a handout, Exhibit A, which is included in the committee records.

Without objection, House Concurrent Resolution No. 54 was reported with amendments by a vote of 13 yeas and 0 nays. Without objection, the amendments were adopted by a vote of 13 yeas and 0 nays. Representatives Miller, Berault, Butler, Chassion, Dickerson, Echols, Egan, Fisher, Jackson, McMahan, Spell, Stagni, and Turner voted yea.

Ralph Abraham, Louisiana Surgeon General, 628 North Fourth Street, Baton Rouge, LA 70802, spoke in support of Senate Bill No. 19.

Representative Stagni offered amendments to add that a pharmacist may dispense ivermectin to any person over the age of 18 pursuant to a standing order issued by a healthcare professional with prescriptive authority in the La. Dept. of Health. Representative Stagni offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 12 yeas and 0 nays. Representatives Miller, Berault, Butler, Chassion, Echols, Egan, Fisher, Jackson, McMahan, Spell, Stagni, and Turner voted yea.

Representative Egan offered an amendment to give parish councils, police juries, and city councils the authority to approve fluoride in public water systems and to prevent the issue from being decided by local elections. Representative Egan offered a motion to adopt the proposed amendment, to which Representative Butler objected. The administrative assistant called the roll, and the motion failed to pass by a vote of 4 yeas and 11 nays. Representatives Crews, Dickerson, Echols, and Egan voted yea. Representatives Miller, Berault, Butler, Chassion, Chenevert, Fisher, Hughes, Jackson, McMahan, Stagni, and Turner voted nay.

Representative Crews offered a motion to report Senate Bill No. 2 favorably, to which Representative Stagni objected. The administrative assistant called the roll, and the motion failed to pass by a vote of 5 yeas and 10 nays. Representatives Crews, Dickerson, Echols, Egan, and Turner voted yea. Representatives Miller, Berault, Butler, Chassion, Chenevert, Fisher, Hughes, Jackson, McMahan, and Stagni voted nay.

Representative Stagni offered a motion to involuntarily defer action on Senate Bill No. 2. Without objection, action on Senate Bill No. 2 was involuntarily deferred by a vote of 15 yeas and 0 nays. Representatives Miller, Berault, Butler, Chassion, Chenevert, Crews, Dickerson, Echols, Egan, Fisher, Hughes, Jackson, McMahan, Stagni, and Turner voted yea.

**Senate Concurrent Resolution No. 9 by Senator Duplessis**

Senator Duplessis presented Senate Concurrent Resolution No. 9, which creates a task force to study and report on strategies to increase engagement of fathers in the lives of their children.

Representative Miller offered technical amendments. Representative Miller offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 13 yeas and 0 nays. Representatives Miller, Berault, Chassion, Crews, Dickerson, Echols, Egan, Fisher, Hughes, Jackson, McMahan, Stagni, and Turner voted yea.

Representative Stagni offered a motion to report Senate Concurrent Resolution No. 9 with amendments. Without objection, Senate Concurrent Resolution No. 9 was reported with amendments by a vote of 13 yeas and 0 nays. Representatives Miller, Berault, Chassion, Crews, Dickerson, Echols, Egan, Fisher, Hughes, Jackson, McMahan, Stagni, and Turner voted yea.

**Senate Bill No. 153 by Senator Selders**

Senator Selders presented Senate Bill No. 153, which provides relative to behavioral health rehabilitation services in the Louisiana medical assistance program.

Representative Miller offered amendments to remove the requirements for licensed professional counselors, provisional licenses, temporary licenses, temporary provisional licenses, renewal of licenses, and temporary provisional licenses and to make technical changes. Representative Miller offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 11 yeas and 0 nays. Representatives Miller, Berault, Chassion, Crews, Dickerson, Echols, Egan, Jackson, McMahan, Stagni, and Turner voted yea.

Stephen Wright, Louisiana Chapter of the National Association of Social Workers, 700 North Tenth Street, Suite 200, Baton Rouge, LA 70802, spoke in opposition to Senate Bill No. 153.

Representative Jackson offered a motion to report Senate Bill No. 153 with amendments. Without objection, Senate Bill No. 153 was reported with amendments by a vote of 12 yeas and 0 nays. Representatives Miller, Berault, Chassion, Crews, Dickerson, Echols, Egan, Fisher, Hughes, Jackson, McMahan, and Turner voted yea.

Representative Chassion offered a motion to report Senate Concurrent Resolution No. 13 favorably. Without objection, Senate Concurrent Resolution No. 13 was reported favorably by a vote of 10 yeas and 0 nays. Representatives Miller, Berault, Chassion, Crews, Echols, Egan, Fisher, Jackson, McMahan, and Turner voted yea.

### **House Concurrent Resolution No. 55 by Representative Miller**

Representative Miller presented House Concurrent Resolution No. 55, which continues the Health Inequities and Disparities in Rural Areas Task Force.

Representative Chassion offered a motion to report House Concurrent Resolution No. 55 favorably. Without objection, House Concurrent Resolution No. 55 was reported favorably by a vote of 9 yeas and 0 nays. Representatives Miller, Berault, Chassion, Crews, Egan, Fisher, Jackson, McMahan, and Turner voted yea.

**Senate Bill No. 174 by Senator Jackson-Andrews**

Representative Miller offered amendments to change "physician" to "healthcare provider" and to make technical changes. Representative Miller offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 9 yeas and 0 nays. Representatives Miller, Berault, Chassion, Crews, Egan, Fisher, Jackson, McMahan, and Turner voted yea.

Representative Chassion offered a motion to report Senate Bill No. 174 with amendments. Without objection, Senate Bill No. 174 was reported with amendments by a vote of 9 yeas and 0 nays. Representatives Miller, Berault, Chassion, Crews, Egan, Fisher, Jackson, McMahan, and Turner voted yea.

**Senate Concurrent Resolution No. 27 by Senator McMath**

Without objection, Senate Concurrent Resolution No. 27 was reported favorably by a vote of 9 yeas and 0 nays. Representatives Miller, Berault, Chassion, Crews, Egan, Fisher, Jackson, McMahan, and Turner voted yea.
