III. DISCUSSION OF LEGISLATION

House Bill No. 69 by Representative Jordan

Representative Jordan presented House Bill No. 69, which provides relative to the Delmont Neighborhood Crime Prevention District in East Baton Rouge Parish.

Representative Marcelle offered a motion to report House Bill No. 69 favorably. Without objection, House Bill No. 69 was reported favorably by a vote of 12 yeas and 0 nays. Representatives Gadberry, Billings, Carver, Cox, Domangue, Farnum, Fontenot, Freiberg, Marcelle, Moore, Newell, and Stagni voted yea.

House Bill No. 649 by Representative Ventrella

Representative Ventrella presented House Bill No. 649, which provides relative to parks and recreation districts in East Baton Rouge Parish.

Representative Ventrella provided a letter from Mayor-President Sid Edwards, expressing that he has no opposition to House Bill No. 649, labeled Exhibit A, a letter from Brandon Noel, Councilman - District 1, in support of House Bill No. 649, labeled Exhibit B, and a letter from Central Community School System in support of House Bill No. 649, labeled Exhibit C, which are included in the committee records.

House Bill No. 106 by Representative Willard

Representative Willard presented House Bill No. 106, which provides relative to the Gentilly Development District in Orleans Parish.

Representative Bayham offered an amendment to change the name of a street within the district's present law boundaries.

Representative Bayham offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 13 yeas and 0 nays. Representatives Gadberry, Bayham, Billings, Cox, Domangue, Farnum, Fontenot, Freiberg, Jackson, Moore, Newell, Owen, and Stagni voted yea.

Representative Stagni offered a motion to report House Bill No. 106 with amendments. Without objection, House Bill No. 106 was reported with amendments by a vote of 13 yeas and 0 nays. Representatives Gadberry, Bayham, Billings, Cox, Domangue, Farnum, Fontenot, Freiberg, Jackson, Moore, Newell, Owen, and Stagni voted yea.

House Bill No. 97 by Representative Bryant

On behalf of Representative Bryant, Representative Willard presented House Bill No. 97, which creates an economic development district in the city of Jeanerette.

Representative Gadberry offered an amendment to limit the means by which the Railroad Avenue Historic Cultural Economic District can acquire property to purchases, gifts, grants, donations, or leases.

Representative Gadberry offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 12 yeas and 0 nays. Representatives Gadberry, Bayham, Billings, Cox, Domangue, Farnum, Fontenot, Jackson, Moore, Newell, Owen, and Stagni voted yea.

Representative Jackson offered a motion to report House Bill No. 97 with amendments. Without objection, House Bill No. 97 was reported with amendments by a vote of 12 yeas and 0 nays. Representatives Gadberry, Bayham, Billings, Cox, Domangue, Farnum, Fontenot, Jackson, Moore, Newell, Owen, and Stagni voted yea.

House Bill No. 107 by Representative Bryant

On behalf of Representative Bryant, Representative Willard presented House Bill No. 107, which creates an economic development district in the city of St. Martinville.

Representative Gadberry offered an amendment to limit the means by which the Greater St. Martinville Economic Development District can acquire property to purchases, gifts, grants, donations, or leases.

Representative Gadberry offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 12 yeas and 0 nays. Representatives Gadberry, Bayham, Billings, Cox, Domangue, Farnum, Fontenot, Jackson, Moore, Newell, Owen, and Stagni voted yea.

Representative Jackson offered a motion to report House Bill No. 107 with amendments. Without objection, House Bill No. 107 was reported with amendments by a vote of 12 yeas and 0 nays. Representatives Gadberry, Bayham, Billings, Cox, Domangue, Farnum, Fontenot, Jackson, Moore, Newell, Owen, and Stagni voted yea.

House Bill No. 446 by Representative Spell

Representative Spell presented House Bill No. 446, which provides relative to the judicial review of land use.

Patrick Ottinger, Lafayette Consolidated Government, 705 West University Avenue, Lafayette, LA 70501, spoke for information only on House Bill No. 446.

Representative Gadberry offered an amendment to add a reference to acts in proposed law provisions relative to grounds for judicial review.

Representative Gadberry offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 12 yeas and 0 nays. Representatives Gadberry, Bayham, Billings, Cox, Domangue, Farnum, Fontenot, Jackson, Moore, Newell, Owen, and Stagni voted yea.

Representative Newell offered a motion to report House Bill No. 446 with amendments. Without objection, House Bill No. 446 was reported with amendments by a vote of 10 yeas and 0 nays. Representatives Gadberry, Bayham, Cox, Domangue, Farnum, Fontenot, Freiberg, Moore, Newell, and Stagni voted yea.

House Bill No. 86 by Representative McMakin

Representative McMakin presented House Bill No. 86, which provides relative to membership of the Recreation and Park Commission for the Parish of East Baton Rouge.

Jennifer Carwile, Together Baton Rouge Big Buddy Program, 1855 Old Carriage Lane, Baton Rouge, LA 70806, spoke in opposition to House Bill No. 86.

Representative Gadberry offered amendments that:

- 1. Authorized each mayor to designate a person to serve in his place on the commission.
- 2. Add four commissioners appointed by the governing authority of the city of Baton Rouge, parish of East Baton Rouge, for three-year terms.
- 3. Increased the quorum requirement from three to five members.

Representative Gadberry offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 10 yeas and 0 nays. Representatives Gadberry, Bayham, Cox, Domangue, Farnum, Fontenot, Freiberg, Moore, Newell, and Stagni voted yea.

Representative Freiberg offered amendments that:

- 1. Add voter and residency requirements for the appointed commissioners.
- 2. Authorized the governing authority of the city of Baton Rouge, parish of East Baton Rouge, to reallocate residency requirements under certain circumstances.

Representative Freiberg offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 11 yeas and 0 nays. Representatives Gadberry, Bayham, Billings, Cox, Domangue, Farnum, Fontenot, Freiberg, Moore, Newell, and Stagni voted yea.

Representative Farnum offered a motion to report House Bill No. 86 with amendments. Without objection, House Bill No. 86 was reported with amendments by a vote of 13 yeas and 0 nays. Representatives Gadberry, Bayham, Billings, Carver, Cox, Domangue, Farnum, Fontenot, Freiberg, Moore, Newell, Owen, and Stagni voted yea.

Witness cards submitted by individuals who did not speak are as follows: 8 in support, 3 in opposition, and 1 for information only. Witness cards are included in the committee records.

House Bill No. 562 by Representative Fontenot

Representative Fontenot presented House Bill No. 562, which provides relative to costs for certain emergency services provided by fire departments and fire protection districts.

Walter Beach, EMS Reform, 13335 West Mill Grove Drive, Gonzales, LA 70737, spoke in support of House Bill No. 562.

Representative Fontenot offered amendments that:

- 1. Authorized nonprofit corporations under contract with a fire protection district to provide emergency services to seek reimbursement pursuant to proposed law.
- 2. Required nonprofit corporations to submit an itemized invoice with corresponding receipts and an explanation of each service for which payment is requested.
- 3. Authorized nonprofit corporations to use any reasonable means to collect and enforce the collection of costs.
- 4. Authorized fire departments, fire protection districts, or nonprofit corporations to seek reimbursement from the automobile insurance company of the individual at fault for a motor vehicle accident for medical costs incurred as the result of a motor vehicle accident.
- 5. Removed provisions that authorize fire departments or fire protection districts to seek reimbursement from an emergency service provider for emergency services provided at the request of the emergency service provider.

Representative Fontenot offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 12 yeas and 0 nays. Representatives Gadberry, Bayham, Billings, Carver, Cox, Domangue, Farnum, Fontenot, Moore, Newell, Owen, and Stagni voted yea.

Representative Fontenot offered a motion to report House Bill No. 562 with amendments. Without objection, House Bill No. 562 was reported with amendments by a vote of 13 yeas and 0 nays. Representatives Gadberry, Bayham, Billings, Carver, Cox, Domangue, Farnum, Fontenot, Freiberg, Knox, Moore, Newell, and Owen voted yea.
