III. DISCUSSION OF LEGISLATION

Senate Bill No. 139 by Senator Price

Senator Price presented Senate Bill No. 139, which provides for the leasing of the Lamar-Dixon Expo Center in Ascension Parish.

Kyle Rogers, Lamar-Dixon, no address provided, spoke in support of Senate Bill No. 139.

Representative Marcelle offered a motion to report Senate Bill No. 139 favorably. Without objection, Senate Bill No. 139 was reported favorably by a vote of 10 yeas and 0 nays. Representatives Gadberry, Billings, Cox, Domangue, Farnum, Freiberg, Knox, Marcelle, Moore, and Stagni voted yea.

Senate Bill No. 77 by Senator Boudreaux

Senator Boudreaux presented Senate Bill No. 77, which provides for naming the recreational complex at Graham Brown Memorial Park in Lafayette in honor of a living person.

Representative Marcelle offered a motion to report Senate Bill No. 77 favorably. Without objection, Senate Bill No. 77 was reported favorably by a vote of 10 yeas and 0 nays. Representatives Gadberry, Billings, Cox, Domangue, Farnum, Freiberg, Knox, Marcelle, Moore, and Stagni voted yea.

Senate Bill No. 107 by Senator Boudreaux

Senator Boudreaux presented Senate Bill No. 107, which provides for the powers and functions of the Lafayette Economic Development Authority.

Mandi Mitchell, Lafayette Economic Development Authority, 211 East Devalcourt Street, no city provided, 70506, spoke in support of House Bill No. 107.

Representative Gadberry offered a motion to report Senate Bill No. 107 favorably. Without objection, Senate Bill No. 107 was reported favorably by a vote of 10 yeas and 0 nays. Representatives Gadberry, Billings, Cox, Farnum, Freiberg, Knox, Marcelle, Moore, Stagni, and Willard voted yea.

Senate Bill No. 187 by Senator Boudreaux

Senator Boudreaux presented Senate Bill No. 187, which provides for the creation of the St. Martin Parish Economic and Industrial Development District.

Jennifer Stelly, Saint Martin Economic Development, 1216 Bushville Highway, no city or state provided spoke in support of House Bill No. 187.

Representative Marcelle offered a motion to report Senate Bill No. 187 favorably. Without objection, Senate Bill No. 187 was reported favorably by a vote of 10 yeas and 0 nays. Representatives Gadberry, Billings, Cox, Farnum, Freiberg, Knox, Marcelle, Moore, Stagni, and Willard voted yea.

Senate Bill No. 237 by Senator Boudreaux

Senator Boudreaux presented Senate Bill No. 237, which provides for the authority of the city of Lafayette and Lafayette Parish to adopt ordinances, rules, and regulations related to dilapidated and dangerous structures.

Representative Stagni offered a motion to report Senate Bill No. 237 favorably. Without objection, Senate Bill No. 237 was reported favorably by a vote of 10 yeas and 0 nays. Representatives Gadberry, Billings, Cox, Farnum, Freiberg, Knox, Marcelle, Moore, Stagni, and Willard voted yea.

Senate Bill No. 142 by Senator Myers

Representative Marcelle offered a motion to report Senate Bill No. 142 favorably. Without objection, Senate Bill No. 142 was reported favorably by a vote of 12 yeas and 0 nays. Representatives Gadberry, Bayham, Billings, Carver, Cox, Farnum, Freiberg, Knox, Marcelle, Moore, Stagni, and Willard voted yea.

Senate Bill No. 60 by Senator Seabaugh

On behalf of Senator Seabaugh, Representative Bamburg presented Senate Bill No. 60, which provides for the abolition of the office of police chief for the village of Hall Summit.

Representative Freiberg offered a motion to report Senate Bill No. 60 favorably. Without objection, Senate Bill No. 60 was reported favorably by a vote of 12 yeas and 0 nays. Representatives Gadberry, Bayham, Billings, Carver, Cox, Farnum, Freiberg, Knox, Marcelle, Moore, Stagni, and Willard voted yea.

Senate Bill No. 103 by Senator Seabaugh

On behalf of Senator Seabaugh, Representative Schamerhorn presented Senate Bill No. 103, which provides for term limits and qualifications for members of the Sabine Parish Police Jury.

Guy Cormier, Police Jury Association of Louisiana, 707 North 7th Street, Baton Rouge, LA 70802, spoke in opposition to Senate Bill No. 103.

Ricky L. Sepulvado, Sabine Parish Policy Jury, 400 South Capitol Street, Many, LA 71449, spoke in opposition to Senate Bill No. 103 and provided handouts, "Sabine Parish Police Jury opposition letter", which is included as Exhibit A in the committee records, "Chief Daniel Thompson opposition letter", which is included as Exhibit B in the committee records, and "Citizens of Sabine Parish signed opposition letters", which is included as Exhibit C in the committee records.

William E. Weatherford, Sabine Policy Jury, 400 South Capitol Street, Room 101, Many, LA 71449, spoke in opposition to Senate Bill No. 103.

Representative Farnum offered a motion to report Senate Bill No. 103 favorably, to which Representative Stagni objected. The administrative assistant called the roll, and the motion failed to pass by a vote of 1 yeas and 10 nays. Representative Farnum voted yea. Representatives Gadberry, Billings, Carver, Cox, Freiberg, Knox, Marcelle, Moore, Stagni, and Willard voted nay.

Senate Bill No. 141 by Senator Connick

Representative Marcelle offered a motion to report Senate Bill No. 141 favorably. Without objection, Senate Bill No. 141 was reported favorably by a vote of 11 yeas and 0 nays. Representatives Gadberry, Billings, Carver, Cox, Farnum, Freiberg, Knox, Marcelle, Moore, Stagni, and Willard voted yea.

Representative Stagni offered a motion to voluntarily defer action on Senate Bill No. 113. Without objection, action on Senate Bill No. 113 was voluntarily deferred by a vote of 11 yeas and 0 nays. Representatives Gadberry, Billings, Carver, Cox, Farnum, Freiberg, Knox, Marcelle, Moore, Stagni, and Willard voted yea.
