**III. DISCUSSION OF LEGISLATION**

**House Bill No. 196 by Representative Stagni**

Representative Stagni presented House Bill No. 196, which authorizes the lease of certain state property in Jefferson Parish and provided a handout, Exhibit A, which is included in the committee records.

**House Bill No. 205 by Representative McCormick**

Representative McCormick presented House Bill No. 205, which provides for the operation of saltwater disposal wells in the parishes of Bienville, Bossier, Caddo, DeSoto, Red River, and Webster.

**House Bill No. 154 by Representative McMahan**

Representative McMahan presented House Bill No. 154, which authorizes the transfer of certain state property in the parishes of Webster and Bienville and provided a handout, Exhibit B, which is included in the committee records.

Representative Orgeron offered a motion to report House Bill No. 154 favorably. Without objection, House Bill No. 154 was reported favorably by a vote of 10 yeas and 0 nays. Representatives Geymann, Braud, Carrier, Coates, Domangue, C. Travis Johnson, Jacob Landry, Mack, McCormick, and Orgeron voted yea.

**House Bill No. 615 by Representative Geymann**

Representative Geymann presented House Bill No. 615, which provides for the regulation of solar facilities and presented a PowerPoint.

Representative Geymann offered a technical amendment. Representative Geymann offered a motion to adopt the proposed amendment. Without objection, the amendment was adopted by a vote of 11 yeas and 0 nays. Representatives Geymann, Braud, Carrier, Coates, Domangue, C. Travis Johnson, Kerner, Jacob Landry, Mack, McCormick, and Orgeron voted yea.

Representative Orgeron offered a motion to invoke the Three-Minute Rule. Without objection, the amendment was adopted by a vote of 11 yeas and 0 nays. Representatives Geymann, Braud, Carrier, Coates, Domangue, C. Travis Johnson, Kerner, Jacob Landry, Mack, McCormick, and Orgeron voted yea.

Representative Geymann offered amendments to:

- (1) Change the vegetative barrier requirement by removing the requirement that evergreen trees be included, to add that the barrier be opaque, and adds an option to retain existing vegetation on site if it otherwise meets the vegetative barrier requirements.
- (2) Change the buffer applicable to natural and navigable waterways from a 500 foot setback with a 200 foot vegetative barrier to a 100 foot vegetative barrier only.
- (3) Change the requirement that all existing facilities come into compliance with the new law by August 1, 2027, to a requirement that all facilities constructed after September 1, 2024, come into compliance with the new law by August 1, 2027, and that

facilities constructed prior to September 1, 2024, will be required to come into compliance with the new laws only to the extent practicable.

(4) Make technical changes.

Representative Orgeron offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 13 yeas and 0 nays. Representatives Geymann, Braud, Carrier, Coates, Domangue, C. Travis Johnson, Kerner, LaCombe, Jacob Landry, Mack, McCormick, Orgeron, and Riser voted yea.

**House Bill No. 459 by Representative Coates**

- (1) Provide an exclusion for applicability of proposed law to residential property use.

- (2) Define "onshore" as land-based wind turbines and those located on inland water bodies.
- (3) Make technical changes.

Representative Coates offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 9 yeas and 0 nays. Representatives Geymann, Braud, Bryant, Carrier, Coates, Domangue, Mack, Riser, and Zeringue voted yea.

Representative Coates offered a motion to report House Bill No. 459 with amendments. Without objection, House Bill No. 459 was reported with amendments by a vote of 9 yeas and 0 nays. Representatives Geymann, Braud, Bryant, Carrier, Coates, Domangue, Mack, Riser, and Zeringue voted yea.
