## **III. DISCUSSION OF LEGISLATION**

### **House Bill No. 601 by Representative Geymann**

*This is a continuation of the discussion on House Bill No. 601 from the meeting held on Tuesday, April 29, 2025. Please check for the prior action to complete the record of discussion and motions on House Bill No. 601.*

Representative Geymann presented House Bill No. 601, which provides relative to carbon dioxide sequestration.

**House Bill No. 548 by Representative LaCombe**

**House Bill No. 632 by Representative Riser**

Representative Riser presented House Bill No. 632, which protects mineral servitude ownership in relation to carbon dioxide sequestration.

Representative Riser offered a motion to voluntarily defer action on House Bill No. 632. Without objection, action on House Bill No. 632 was voluntarily deferred by a vote of 13 yeas and 0 nays. Representatives Geymann, Braud, Carrier, Coates, Dewitt, Domangue, C. Travis Johnson, LaCombe, Jacob Landry, McCormick, Orgeron, Riser, and Ventrella voted yea.

### **House Bill No. 396 by Representative McCormick**

Representative McCormick presented House Bill No. 396, which declares that carbon dioxide sequestration in Louisiana is illegal.

Representative McCormick offered amendments to:

- (1) Make technical changes.
- (2) Make carbon dioxide sequestration illegal beneath private property without the property owner's consent.

Representative McCormick offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 12 yeas and 0 nays. Representatives Geymann, Braud, Carrier, Coates, Dewitt, Domangue, C. Travis Johnson, Jacob Landry, McCormick, Orgeron, Riser, and Ventrella voted yea.

Representative McCormick offered a motion to report House Bill No. 396 with amendments, to which Representative Orgeron objected. The administrative assistant called the roll, and the motion failed to pass by a vote of 3 yeas, 8 nays, and 1 abstention. Representatives Carrier, Dewitt, and McCormick voted yea. Representatives Braud, Domangue, C. Travis Johnson, LaCombe, Jacob Landry, Orgeron, Riser, and Zeringue voted nay. Representative Geymann abstained.

Witness cards submitted by individuals who did not speak are as follows: 19 in support, and 29 in opposition. Witness cards are included in the committee records.

#### **House Bill No. 585 by Representative McCormick**

Representative McCormick presented House Bill No. 585, which requires advance notice to surface and mineral owners prior to permitting or performing carbon dioxide sequestration activities.

Representative McCormick offered a motion to voluntarily defer action on House Bill No. 585. Without objection, action on House Bill No. 585 was voluntarily deferred by a vote of 12 yeas and 0 nays. Representatives Geymann, Braud, Carrier, Dewitt, Domangue, C. Travis Johnson, LaCombe, Jacob Landry, McCormick, Orgeron, Riser, and Zeringue voted yea.

#### **House Bill No. 75 by Representative McCormick**

Representative Geymann offered a motion to invoke the Two-Minute Rule. Without objection, the motion passed by a vote of 11 yeas and 0 nays. Representatives Geymann, Braud, Carrier, Dewitt, Domangue, LaCombe, Jacob Landry, McCormick, Orgeron, Riser, and Zeringue voted yea.

Representative McCormick presented House Bill No. 75, which provides relative to compensation for pore space owners.

Representative McCormick offered amendments to:

- (1) Make technical changes.
- (2) Add a new proposed law provision requiring a unit operator to compensate nonconsenting mineral owners within the unit for the value of their stranded minerals or reimburse them for the additional material costs, as required by the department, to drill through the plume.

- (3) Change the minimum per acre compensation required from the maximum per acre compensation received by any owner in interest in the unit to the average per acre compensation received by all other owners in interest.
- (4) Make the minimum per acre compensation requirement applicable to non-consenting owners in interest only.

Representative McCormick offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 13 yeas and 0 nays. Representatives Geymann, Braud, Carrier, Coates, Dewitt, Domangue, LaCombe, Jacob Landry, Mack, McCormick, Orgeron, Riser, and Zeringue voted yea.

Blake Canfield, DENR, 617 North Third Street, Baton Rouge, LA 70802, spoke for information only on House Bill No. 75.

Representative Geymann offered an amendment that originated in committee to specify that a non-consenting owner in interest shall not be compensated with an amount per acre which is less than the average compensation paid per acre to all other owners in a storage unit. Representative Geymann offered a motion to adopt the proposed amendment. Without objection, the amendment was adopted by a vote of 12 yeas and 0 nays. Representatives Geymann, Braud, Carrier, Coates, Dewitt, Domangue, LaCombe, Mack, McCormick, Orgeron, Riser, and Zeringue voted yea.
