III. DISCUSSION OF LEGISLATION**House Bill No. 164 by Representative Billings**

Representative Billings presented House Bill No. 164, which provides relative to mallard hunting licenses for hunting preserves.

Representative Geymann offered amendments to:

- (1) Change the applicable date for which the hunting preserve was licensed from prior to Jan.1, 2025 to in the 2024 license year.
- (2) Make technical changes.

Representative Geymann offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 11 yeas and 0 nays. Representatives Geymann, Braud, Carrier, Coates, Domangue, C. Travis Johnson, Jacob Landry, McCormick, Orgeron, Riser, and Zeringue voted yea.

- (3) Remove the requirement that charter boat captains' names and locations be provided to the Dept. of Health, office of public health, upon request.

- (2) Change the compensation required to be paid to mineral servitude owners for mineral rights taken or damages from the value of the rights to the fair market value of the rights.
- (3) Remove provision of proposed law providing for interruption of the prescription of non-use.
- (4) Make technical changes.

Representative Riser offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 13 yeas and 0 nays. Representatives Geymann, Braud, Bryant, Carrier, Coates, Domangue, LaCombe, Jacob Landry, Mack, McCormick, Orgeron, Riser, and Zeringue voted yea.

- (1) Change penalty from criminal to civil with a fine of \$200,000.
- (2) Transfer authority to enforce prohibition from state police and law enforcement to the Dept. of Agriculture and Forestry.
- (3) Require radiation evaluation report to be submitted to the Dept. of Environmental Quality rather than the local sheriff.
