Representative Ryan Bourriaque, chair of the House Committee on Transportation, Highways and Public Works, called the meeting to order at 9:32 a.m. in Room 3, in the state capitol in Baton Rouge, Louisiana.

III. DISCUSSION OF LEGISLATION

House Bill No. 209 by Representative Brass

Representative Brass presented House Bill No. 209, which provides relative to the financing structure for public works projects in Ascension Parish.

Richard M. Compton, Ascension Parish Government, 15247 Bayou Trace, Gonzales, LA 70737, spoke in support of House Bill No. 209.

Ruth Phillips, CAO, Ascension Parish Government, 615 E. Worthey St., Gonzales LA, 70737, spoke in support of House Bill No. 209.

Representative Wiley offered an amendment to change the contract amount from in excess of \$50,000 to in excess of \$500,000 for a bond to be required. Representative Wiley offered a motion to adopt the proposed amendment. Without objection, the amendment was adopted by a vote of 9 yeas and 0 nays. Representatives Bourriaque, Boyer, Braud, Dickerson, Fontenot, Moore, Schamerhorn, Spell, and Wiley voted yea.

Derrell Cohoon, AGC, 714 N. 5th St., Baton Rouge, LA 70802, spoke in opposition to House Bill No. 209.

Representative Wiley offered a motion to report House Bill No. 209 with amendments, to which Representative Schamerhorn objected. The administrative assistant called the roll, and House Bill No. 209 was reported with amendments by a vote of 10 yeas and 1 nays. Representatives Bourriaque, Boyer, Braud, Dickerson, Fontenot, Jackson, Moore, Phelps, Spell, and Wiley voted yea. Representative Schamerhorn voted nay.

House Bill No. 167 by Representative Taylor

Representative Taylor presented House Bill No. 167, which designates a portion of Louisiana Highway 3188 as the "Veterans Memorial Highway".

Joseph Accardo Jr., Self, American Legion Post 383, 52 Holly Dr., Laplace, LA 70068, spoke in support of House Bill No. 167 and provided a handout, Exhibit A, which is included in the committee records.

Representative Jackson offered a motion to report House Bill No. 167 favorably. Without objection, House Bill No. 167 was reported favorably by a vote of 12 yeas and 0 nays. Representatives Bourriaque, Boyer, Braud, Dickerson, Fontenot, Jackson, Moore, Phelps, Schamerhorn, Spell, Tarver, and Wiley voted yea.

House Bill No. 312 by Representative Gadberry

Representative Gadberry presented House Bill No. 312, which prohibits the state and any of its political subdivisions or agencies from using price or price-related information as a factor in the selection of architectural and engineering professional services for certain projects.

Representative Jackson offered an amendment to make technical changes. Representative Jackson offered a motion to adopt the proposed amendments. Without objection, the amendment was adopted by a vote of 12 yeas and 0 nays. Representatives Bourriaque, Boyer, Braud, Dickerson, Fontenot, Jackson, Moore, Phelps, Schamerhorn, Spell, Tarver, and Wiley voted yea.

Barker Dirmann, ACEC Louisiana, 9643 Brookline, Ave., Baton Rouge, LA 70709, spoke in support of House Bill No. 312.

Representative Jackson offered a motion to report House Bill No. 312 with amendments. Without objection, House Bill No. 312 was reported with amendments by a vote of 12 yeas and 0 nays. Representatives Bourriaque, Boyer, Braud, Dickerson, Fontenot, Jackson, Moore, Phelps, Schamerhorn, Spell, Tarver, and Wiley voted yea.

House Bill No. 508 by Representative Larvadain

Representative Larvadain presented House Bill No. 508, which restricts a parking fee exemption to Louisiana disabled veterans parking at cruise terminals for the Port of New Orleans.

Representative Boyer offered a motion to report House Bill No. 508 favorably. Without objection, House Bill No. 508 was reported favorably by a vote of 11 yeas and 0 nays. Representatives Bourriaque, Boyer, Braud, Dickerson, Jackson, Moore, Phelps, Schamerhorn, Spell, Tarver, and Wiley voted yea.

House Bill No. 524 by Representative Spell

Representative Spell presented House Bill No. 524, which provides relative to fire departments and public safety departments or agencies entering into an agreement with group purchasing organizations.

Representative Dickerson offered a motion to report House Bill No. 524 favorably. Without objection, House Bill No. 524 was reported favorably by a vote of 11 yeas and 0 nays. Representatives Bourriaque, Boyer, Braud, Dickerson, Jackson, Moore, Phelps, Schamerhorn, Spell, Tarver, and Wiley voted yea.

House Bill No. 620 by Representative Phelps

Representative Phelps presented House Bill No. 620, which establishes procedures to eliminate traffic congestion in neighborhoods surrounding certain schools in Shreveport, Louisiana.

Representative Phelps offered amendments to:

- (1) Make technical changes.
- (2) Add additional roadways to the access restrictions applicable during drop-off and pick-up times.

Representative Phelps offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 9 yeas and 0 nays. Representatives Bourriaque, Boyer, Dickerson, Jackson, Moore, Phelps, Spell, Tarver, and Wiley voted yea.

J. Kent Rogers, NLCOG, 625 Texas St., Suite 200, Shreveport, LA 71101, spoke in support of House Bill No. 620 and provided a handout, Exhibit B, which is included in the committee records.

Representative Jackson offered a motion to report House Bill No. 620 with amendments. Without objection, House Bill No. 620 was reported with amendments by a vote of 12 yeas and 0 nays. Representatives Bourriaque, Boyer, Braud, Dickerson, Fontenot, Jackson, Moore, Phelps, Schamerhorn, Spell, Tarver, and Wiley voted yea.

House Bill No. 616 by Representative Wright

Representative Wright presented House Bill No. 616, which authorizes the Port of New Orleans to utilize public private partnerships for certain projects.

Jean-Paul Escudier, Port of New Orleans, 1350 Port of New Orleans Pl., New Orleans, LA 70130, spoke in support of House Bill No. 616.

Representative Bourriaque offered amendments to:

- (1) Expands what can be included in the public-private partnership projects.
- (2) Specifies what relocation obligation certain entities may have if their facilities will be affected by a roadway project.
- (3) Adds that the board may also accept financing from the United States or state of Louisiana for projects.
- (4) Adds that the board must comply with the requirements to file a sworn statement of amounts due with the Department of Transportation and Development and all of the department's payment requirements and that the board is substituted for the authority of the project.
- (5) Specifies that the board controls access to the roadway, allowing entry only at designed points.
- (6) Specifies that the board determines and approves the connections granted to municipal, parish, or state highways to the roadway.

- (7) Removes a requirement that the board notify other relevant entities, in addition to local governmental subdivisions, before establishing any controlled-access roadways.
- (8) Specifies that the board's expropriation may be from legal entities that may have power of expropriation, and no recriminatory expropriation can be allowed against the board.
- (9) Specifies entry and use of private property, with consent not obtained by the owner, cannot be considered trespassing or a taking under expropriation statutes for purposes of the roadway project.
- (10) Clarifies that the board has full power and authority without any statutory limitations that might otherwise exist in any area outside of Subpart D of Part 2 of Chapter 1 of title 34 of the La. Revised Statues.
- (11) Make technical changes.

Representative Bourriaque offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 12 yeas and 0 nays. Representatives Bourriaque, Boyer, Braud, Chassion, Dickerson, Jackson, Moore, Phelps, Schamerhorn, Spell, Tarver, and Wiley voted yea.

Representative Phelps offered a motion to voluntarily defer action on House Bill No. 616, to which Representative Tarver objected. Representative Tarver offered a substitute motion to report House Bill No. 616 with amendments, to which Representative Phelps objected. The administrative assistant called the roll, the substitute motion to report House Bill No. 616 with amendments failed to pass by a vote of 4 yeas and 7 nays. Representatives Bourriaque, Fontenot, Tarver, and Wiley voted yea. Representatives Boyer, Braud, Dickerson, Jackson, Moore, Phelps, and Spell, voted nay.

The original motion to voluntarily defer action on House Bill No. 616 was considered. Without objection, House Bill No. 616 was voluntarily deferred by a vote of 11 yeas and 0 nays. Representatives Bourriaque, Boyer, Braud, Dickerson, Fontenot, Jackson, Moore, Phelps, Spell, Tarver, and Wiley voted yea.

Witness cards submitted by individuals who did not speak are as follows: 7 in support, 7 in opposition, and 2 for information only. Witness cards are included in the committee records.

Without objection, the motion passed by a vote of 11 yeas and 0 nays. Representatives Bourriaque, Boyer, Braud, Dickerson, Fontenot, Jackson, Moore, Phelps, Spell, Tarver, and Wiley voted yea.

Consideration and adoption of committee minutes dated July 27, 2023 and November 20, 2024

The minutes from the 2023-2024 Interim dated July 27, 2023 and November 20, 2024 were presented to the committee for approval. Representative Jackson offered a motion to approve the

minutes. Without objection, the minutes were approved by a vote of 11 yeas and 0 nays. Representatives Bourriaque, Boyer, Braud, Dickerson, Fontenot, Jackson, Moore, Phelps, Spell, Tarver, and Wiley voted yea.
