### **III. DISCUSSION OF LEGISLATION**

#### **House Bill No. 519 by Representative Glorioso**

Representative Glorioso presented House Bill No. 519, which provides relative to the operation of a motor vehicle while using a wireless telecommunication device.

### **House Bill No. 232 by Representative Bagley**

Representative Bagley presented House Bill No. 232, which eliminates the state inspection sticker requirement for certain vehicles.

Representatives Bourriaque, Boyer, Chassion, Dickerson, Fontenot, Jackson, Moore, Phelps, Schamerhorn, Spell, Tarver, and Wiley voted yea.

Representatives Boyer, Chassion, Moore, Phelps, Spell, and Wiley voted nay.

**House Bill No. 221 by Representative Bagley**

Representative Bourriaque offered a motion to voluntarily defer action on House Bill No. 221, which provides relative to a motor vehicle inspection tax. Without objection, action on House Bill No. 221 was voluntarily deferred by a vote of 11 yeas and 0 nays. Representatives Bourriaque, Boyer, Chassion, Dickerson, Fontenot, Moore, Phelps, Schamerhorn, Spell, Tarver, and Wiley voted yea.

**House Bill No. 499 by Representative Bamburg**

Representative Bamburg presented House Bill No. 499, which establishes penalties for persons exceeding the speed limit or breaching construction zones and utility work safety zones under active construction with workers on site.

Representative Chassion offered a motion to report House Bill No. 499 favorably. Without objection, House Bill No. 499 was reported favorably by a vote of 11 yeas and 0 nays. Representatives Bourriaque, Boyer, Chassion, Dickerson, Fontenot, Moore, Phelps, Schamerhorn, Spell, Tarver, and Wiley voted yea.

**House Bill No. 630 by Representative Bayham**

Representative Bayham presented House Bill No. 630, which reduces the fee applicable to updating a driver's license to comply with REAL ID standards.

Representative Bourriaque offered amendments in the form of a substitute bill. Representative Bourriaque offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 10 yeas and 0 nays. Representatives Bourriaque, Boyer, Chassion, Dickerson, Fontenot, Moore, Schamerhorn, Spell, Tarver, and Wiley voted yea.

Representative Tarver offered a motion to report House Bill No. 630 by substitute. Without objection, House Bill No. 630 was reported by substitute by a vote of 10 yeas and 0 nays. Representatives Bourriaque, Boyer, Chassion, Dickerson, Fontenot, Moore, Schamerhorn, Spell, Tarver, and Wiley voted yea.

**House Bill No. 631 by Representative Bayham**

Representative Bayham presented House Bill No. 631, which reduces the fee applicable to updating a name on a driver's license.

Representative Bourriaque offered amendments in the form of a substitute bill. Representative Bourriaque offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 10 yeas and 0 nays. Representatives Bourriaque, Boyer, Chassion, Dickerson, Fontenot, Moore, Schamerhorn, Spell, Tarver, and Wiley voted yea.

Representative Tarver offered a motion to report House Bill No. 631 by substitute. Without objection, House Bill No. 631 was reported by substitute by a vote of 10 yeas and 0 nays. Representatives Bourriaque, Boyer, Chassion, Dickerson, Fontenot, Moore, Schamerhorn, Spell, Tarver, and Wiley voted yea.

**House Bill No. 476 by Representative Fontenot**

Representative Fontenot presented House Bill No. 476, which provides relative to an annual automatic adjustment to a fee for motor vehicle dealers based on the Consumer Price Index.

Representative Bourriaque offered an amendment originated in committee to add that the Federal Consumer Price Index for all Urban Consumers or CPI-U cannot exceed 3% for a calendar year. Representative Bourriaque offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 9 yeas and 0 nays. Representatives Bourriaque, Boyer, Dickerson, Fontenot, Jackson, Schamerhorn, Spell, Tarver, and Wiley voted yea.

Stephen A. Quidd, OMV, P.O. Box 64886, Baton Rouge, LA 70892, spoke for information only on House Bill No. 476.

Representative Bourriaque offered a motion to report House Bill No. 476 with amendments. Without objection, House Bill No. 476 was reported with amendments by a vote of 9 yeas and 0 nays. Representatives Bourriaque, Boyer, Dickerson, Fontenot, Jackson, Schamerhorn, Spell, Tarver, and Wiley voted yea.

#### **House Bill No. 119 by Representative Deshotel**

On behalf of Representative Deshotel, Representative Fontenot, presented House Bill No. 119, which decreases the minimum light transmission percentage allowable for the front side window tint of motor vehicles.

Representative Schamerhorn offered a motion to report House Bill No. 119 favorably. Without objection, House Bill No. 119 was reported favorably by a vote of 9 yeas and 0 nays. Representatives Bourriaque, Boyer, Chassion, Dickerson, Fontenot, Jackson, Schamerhorn, Spell, and Tarver voted yea.

Witness cards submitted by individuals who did not speak are as follows: 1 in support, 1 in opposition, and 1 for information only. Witness cards are included in the committee records.

#### **House Bill No. 301 by Representative Domangue**

On behalf of Representative Domangue, Representative Bourriaque presented House Bill No. 301, which provides for the removal and salvage of abandoned vessels in waterways.

Representative Bourriaque offered amendments in the form of a substitute bill. Representative Bourriaque offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 9 yeas and 0 nays. Representatives Bourriaque, Boyer, Chassion, Dickerson, Fontenot, Jackson, Schamerhorn, Spell, and Tarver voted yea.

Representative Chassion offered a motion to report House Bill No. 301 by substitute. Without objection, House Bill No. 301 was reported by substitute by a vote of 9 yeas and 0 nays. Representatives Bourriaque, Boyer, Chassion, Dickerson, Fontenot, Jackson, Schamerhorn, Spell, and Tarver voted yea.

### **House Bill No. 170 by Representative Cox**

Representative Cox presented House Bill No. 170, which removes the requirement that taxi cab drivers obtain a chauffeur's license.

Representative Chassion offered a motion to report House Bill No. 170 favorably. Without objection, House Bill No. 170 was reported favorably by a vote of 8 yeas and 0 nays. Representatives Bourriaque, Boyer, Chassion, Dickerson, Jackson, Schamerhorn, Spell, and Tarver voted yea.

### **House Bill No. 554 by Representative McMakin**

Representative McMakin presented House Bill No. 554, which establishes a notice of voting restriction and a restriction code applicable to persons who are not United States citizens and aliens lawfully present in the United States but have not attained United States citizenship.

Representatives Bourriaque, Boyer, Chassion, Dickerson, Fontenot, Schamerhorn, Spell, Tarver, and Wiley voted yea. Representative Phelps voted nay.
