### **I. CALL TO ORDER**

Representative Ryan Bourriaque, chair of the House Committee on Transportation, Highways and Public Works, called the meeting to order at 9:34 a.m. in Room 3, in the state capitol in Baton Rouge, Louisiana.

### **III. DISCUSSION OF LEGISLATION**

#### **House Bill No. 613 by Representative Beaulieu**

Representative Beaulieu presented House Bill No. 613, which creates the Iberia Parish Airport Authority.

Representative Bourriaque offered amendments to:

- (1) Make technical changes.
- (2) Clarify that the domicile of the district may be changed to any location within the district boundaries or to the seat of any political subdivision partially located within the district, subject to approval of the board.

Representative Bourriaque offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 10 yeas and 0 nays. Representatives Bourriaque, Braud, Dickerson, Fontenot, Moore, Phelps, Schamerhorn, Spell, Tarver, and Wiley voted yea.

Representative Bourriaque offered amendments to:

- (1) Specify that upon the approvals of the Iberia Parish Council and the Federal Aviation Administration, the Acadiana Regional Airport and Lemaire Memorial Airport District will be established.
- (2) Authorize the Iberia Parish Council authority to appoint all members of the board and to remove and replace any member by majority vote.
- (3) Require two members to be domiciled in the city of New Iberia and one in the city of Jeanerette.
- (4) Change the quorum requirements for the board from three members to four members.

Representative Bourriaque offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 10 yeas and 0 nays. Representatives Bourriaque, Braud, Dickerson, Fontenot, Moore, Phelps, Schamerhorn, Spell, Tarver, and Wiley voted yea.

Patrick Norris, Airport Commission, New Iberia, LA, spoke in support of House Bill No. 613.

Lady Fontenette Brown, Iberia Parish District 12, 1402 MLK Dr., Jeanerette, LA 70544, spoke in opposition of House Bill No. 613.

Representative Fontenot offered a motion to invoke the Three-Minute Rule. Without objection, the motion passed by a vote of 10 yeas and 0 nays. Representatives Bourriaque, Braud, Dickerson, Fontenot, Moore, Phelps, Schamerhorn, Spell, Tarver, and Wiley voted yea.

M. Larry Richard, parish president, Iberia Parish Government, 300 Iberia St., New Iberia, LA 70560, spoke in opposition to House Bill No. 613.

Representative Fontenot offered a motion to report House Bill No. 613 with amendments. Without objection, House Bill No. 613 was reported with amendments by a vote of 10 yeas and 0 nays. Representatives Bourriaque, Braud, Dickerson, Fontenot, Moore, Phelps, Schamerhorn, Spell, Tarver, and Wiley voted yea.

### **House Bill No. 588 by Representative Mena**

Representative Mena presented House Bill No. 588, which provides relative to the Regional Transit Authority.

Representative Bourriaque offered amendments to:

- (1) Make technical changes.
- (2) Delete the requirement that the business agent have appointing authority to appoint one local member of the Amalgamated Transit Union of the RTA.
- (3) Add that one union representative from the International Brotherhood of Electrical Workers, the United Labor Union, or any other labor union that is formed in the future will represent RTA workers. Further provides for a rotating two-year appointment and will be nominated by the relevant RTA local labor unions.
- (4) Delete present law that included two members of the Louisiana American Federation of Labor and Congress of the Louisiana Industrial Organizations be members of the advisory board.

Representative Bourriaque offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 10 yeas and 0 nays. Representatives Bourriaque, Braud, Dickerson, Fontenot, Moore, Phelps, Schamerhorn, Spell, Tarver, and Wiley voted yea.

Representative Moore offered a motion to report House Bill No. 588 with amendments. Without objection, House Bill No. 588 was reported with amendments by a vote of 10 yeas and 0 nays. Representatives Bourriaque, Braud, Dickerson, Fontenot, Moore, Phelps, Schamerhorn, Spell, Tarver, and Wiley voted yea.

#### **House Bill No. 480 by Representative McCormick**

Representative Bourriaque offered a motion to voluntarily defer action on House Bill No. 480, which provides relative to the authority of the Caddo-Bossier Parishes Port Commission to use the payment in lieu of taxes program. Without objection, action on House Bill No. 480 was voluntarily deferred by a vote of 11 yeas and 0 nays. Representatives Bourriaque, Braud, Chassion, Dickerson, Fontenot, Moore, Phelps, Schamerhorn, Spell, Tarver, and Wiley voted yea.

#### **House Bill No. 660 by Representative Boyd**

Representative Boyd presented House Bill No. 660, which provides relative to the annual registration tax applicable to trucks and trailers statewide.

Renee Amar, LMTA, 325 Florida, St., Baton Rouge, LA 70801, spoke in opposition to House Bill No. 660.

Representative Phelps offered a motion to report House Bill No. 660 favorably, to which Representative Tarver objected. The administrative assistant called the roll, and House Bill No. 660 was reported favorably by a vote of 6 yeas, 3 nays, and 1 abstention. Representatives Braud, Chassion, Moore, Phelps, Spell, and Wiley voted yea. Representatives Dickerson, Schamerhorn, and Tarver voted nay. Representative Bourriaque abstained.

#### **House Bill No. 616 by Representative Wright**

Representative Wright presented House Bill No. 616, which authorizes the Port of New Orleans to utilize public private partnerships for certain projects.
