III. DISCUSSION OF LEGISLATION**House Resolution No. 40 by Representative Taylor**

Representative Taylor presented House Resolution No. 40, which urges and requests the Department of Transportation and Development to study and take measures on the benefits of connecting West 10th Street in Reserve, Louisiana, to Interstate 10 to relieve traffic congestion.

Representative Walters offered a motion to report House Resolution No. 40 favorably. Without objection, House Resolution No. 40 was reported favorably by a vote of 11 yeas and 0 nays. Representatives Bourriaque, Boyer, Braud, Dickerson, Fontenot, Moore, Schamerhorn, Spell, Tarver, Walters, and Wiley voted yea.

House Concurrent Resolution No. 71 by Representative Crews

Representative Crews presented House Concurrent Resolution No. 71, which memorializes Congress to consider eliminating the Transportation Security Administration at airports and shift the responsibility to airline employees.

Representative Schamerhorn offered amendments in the form of a substitute bill. Representative Schamerhorn offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 11 yeas and 0 nays. Representatives Bourriaque, Boyer, Braud, Dickerson, Fontenot, Moore, Schamerhorn, Spell, Tarver, Walters, and Wiley voted yea.

Representative Schamerhorn offered a motion to report House Concurrent Resolution No. 71 by substitute. Without objection, House Concurrent Resolution No. 71 was reported by substitute by a vote of 11 yeas and 0 nays. Representatives Bourriaque, Boyer, Braud, Dickerson, Fontenot, Moore, Schamerhorn, Spell, Tarver, Walters, and Wiley voted yea.

House Resolution No. 204 by Representative Walters

Representative Walters presented House Resolution No. 204, which urges and requests that the legislature establish the Louisiana Auto Manufacturing Fund.

Representative Walters offered a motion to voluntarily defer action on House Resolution No. 204. Without objection, action on House Resolution No. 204 was voluntarily deferred by a vote of 11 yeas and 0 nays. Representatives Bourriaque, Boyer, Braud, Dickerson, Fontenot, Moore, Schamerhorn, Spell, Tarver, Walters, and Wiley voted yea.

House Resolution No. 220 by Representative Braud

Representative Braud presented House Resolution No. 220, which urges and requests the Department of Transportation and Development to study Geaux Pass toll functions, accessibility to the public, potential improvements to Geaux Pass customer service, causes for the delay in the commencement of Geaux Pass for the Belle Chasse bridge project, and recommend improvements for future projects.

Keith Hinkley, Plaquemines Parish, 333 F. Edward Hebert, Belle Chasse, LA 70037, spoke in support of House Resolution No. 220.

Representative Braud offered a motion to report House Resolution No. 220 favorably. Without objection, House Resolution No. 220 was reported favorably by a vote of 12 yeas and 0 nays. Representatives Bourriaque, Boyer, Braud, Dickerson, Fontenot, Moore, Phelps, Schamerhorn, Spell, Tarver, Walters, and Wiley voted yea.

House Concurrent Resolution No. 66 by Representative Braud

Representative Braud presented House Concurrent Resolution No. 66, which urges and requests the office of motor vehicles and the Louisiana State Police to study methods of enforcing out-of-state vehicle insurance compliance.

Representative Braud offered a motion to report House Concurrent Resolution No. 66 favorably. Without objection, House Concurrent Resolution No. 66 was reported favorably by a vote of 12 yeas and 0 nays. Representatives Bourriaque, Boyer, Braud, Dickerson, Fontenot, Moore, Phelps, Schamerhorn, Spell, Tarver, Walters, and Wiley voted yea.

Without objection, House Concurrent Resolution No. 68 was reported favorably by a vote of 12 yeas and 0 nays. Representatives Bourriaque, Boyer, Braud, Dickerson, Fontenot, Moore, Phelps, Schamerhorn, Spell, Tarver, Walters, and Wiley voted yea.
