HOUSE BILL NO. 1—

BY REPRESENTATIVES ALARIO AND TRICHE AN ACT

Making appropriations for the ordinary expenses of the executive branch of state government, pensions, public schools, public roads, public charities, and state institutions and providing with respect to the expenditure of said appropriations.

Read by title.

Suspension of the Rules

Rep. Murray moved to suspend House Rule 6.25 for the consideration of House Bill No. 1.

Rep. Bruneau objected.

By a vote of 62 yeas and 25 nays, the House agreed to suspend House Rule 6.25.

Rep. Crowe sent up floor amendments which were read as follows:

"In the event Senate Bill No. 762 of the 2004 Regular Session of the Legislature is enacted into law, and in the event the state interest in the tract of land owned by Southeast Louisiana State Hospital located in Section 42, Township 8S, Range 12E in St. Tammany Parish, totalling between seven hundred and eight hundred acres located north and east of the sewerage treatment ponds is sold, and the proceeds of such sale are deposited into the State General Fund, an amount not to exceed Nine Million and No/100 (\$9,000,000.00) Dollars, or an amount equal to the sale proceeds deposited into the State General Fund if such proceeds are less than \$9,000,000.00, is hereby appropriated from the State General Fund (Direct) for construction of an interchange at the intersection of I-12 and Louisiana Highway No. 1088."

Rep. Crowe moved the adoption of the amendments.
