AN ACT To amend and reenact R.S. 3:1355(A) and to enact R.S. 3:1355(B), R.S. 14:67.19.1 and R.S. 40:962.1.2, relative to certain controlled dangerous substances; to prohibit the unauthorized possession of anhydrous ammonia for use in the sale of certain controlled dangerous substances; to restrict the sale of ephedrine, pseudoephedrine, or phenylpropanolamine or their salts, optical isomers and salts of optical isomers used in the manufacture of methamphetamines; to require that pharmacies maintain records on purchases of certain restricted substances used to manufacture methamphetamine; to provide exceptions for substances formulated so as to prevent conversion of certain active ingredients; and to provide for related matters.

HOUSE BILL NO. 123

BY REPRESENTATIVES DOWNS AND GALLOT AN ACT

To enact R.S. 36:509(U) and Part XXXI of Chapter 13 of Title 38 of the Louisiana Revised Statutes of 1950, to be comprised of R.S. 38:3087.281 through 3087.295, relative to the Lincoln Parish Reservoir Authority; to create the Lincoln Parish Reservoir Authority as a state agency; to provide for a board of commissioners to manage the reservoir authority; to provide for the reimbursement of the amount originally paid for property returned to a prior landowner; to limit the authority of the district to expropriate property; to provide for the powers and duties of the authority including the authority to issue bonds; to prohibit certain actions; to provide for penalties; to provide relative to the authority's relationship with the Department of Transportation and Development and the Louisiana Wildlife and Fisheries Commission; and to provide for related matters.

On page 1, line 6, after "authority;" and before "to" insert the following:

"to provide for the reimbursement of the amount originally paid for property returned to a prior landowner; to limit the authority of the district to expropriate property'

However, in lieu of purchasing the property, the authority may obtain a flood servitude or flowage easement, upon payment of a negotiated amount, on that land located between the normal pool stage and the maximum flood elevation as determined by the authority.

"(2)(a)(i) Any expropriation exercised pursuant to this Subsection shall, except as provided in this Paragraph, be conducted pursuant to the general expropriation provisions for expropriation by the state or its political subdivisions contained in Part I of Title 19 of the Louisiana Revised Statutes of 1950.

(ii) Prior to purchasing property or exercising its power of expropriation, the authority shall have the property appraised by an independent appraiser licensed in the state of Louisiana to determine the amount of compensation to be paid the landowner for his property. If an agreement as to compensation cannot be reached between the district and the landowner, then either party may exercise his right to a jury trial under Article I, Section 4 of the Constitution of Louisiana to determine the amount of compensation to be paid.

(b)(i) If a residential mobile home, as defined in R.S. 9: 1149.2(10), is located on land to be taken by the authority through expropriation, the authority shall make every reasonable effort to relocate the existing residential mobile home to a location within the authority as close as practicable to its current location, unless the owner receives the amount due him as allowed by law.

(ii) If a private residence has been built on land to be taken by the authority through expropriation, the authority shall make every reasonable effort to accommodate the owner of the residence either by payment of compensation or by constructing a new home for the owner on land located as near as practicable to its current location unless another location is specified by the owner and provided the cost of a new residence does not exceed the amount due the owner as allowed by law.

(2) Parishes with a population not less than one hundred twentysix thousand and not more than one hundred twenty-seven thousand according to the most recent federal decennial census.

(3) Parishes with a population not less than two hundred fifty-two thousand and not more than two hundred fifty-three thousand according to the most recent federal decennial census.

(4) Parishes with a population not less than one hundred eightythree thousand and not more than one hundred eighty-four thousand according to the most recent federal decennial census."
