## HOUSE BILL NO. 1227— BY REPRESENTATIVE SMILEY

AN ACT To amend and reenact R.S. 22:1404(E), relative to fire insurance rates; to require that the global positioning system (GPS) be used to determine the location of residential structures within a public fire protection area for purposes of fire insurance rates; to further require that longitude and latitude coordinates obtained using GPS of such structures be noted upon certain insurance policies or addenda at the time of either policy issuance or renewal; and to provide for related matters.


