The State Board of Elementary and Secondary Education shall adopt regulations to insure instruction required herewith is given to all pupils in all public high schools and local boards of education of every city, parish and school district of this state shall schedule such instruction in accordance with said regulations of the State Board of Elementary and Secondary Education. In-service training programs shall be provided each year by the State Department of Education to assist teachers who give instruction on the free enterprise system.

D. The state superintendent of education shall have the authority at any time to waive such requirement for any person who is on active duty in the Armed Forces of the United States and who was transferred into the state during his senior year. The state
