Employment of retirees; salary; contracts; terms and conditions of reemployment

A.(1)(a) Except as otherwise provided in Subparagraph (b) of this Paragraph, the salary of any retiree who is reemployed as a full-time teacher pursuant to the provisions of this Section shall be based on the salary schedule which accounts for all prior years of teaching service and pertinent experience.

(b)(i) Notwithstanding any law, rule, or regulation to the contrary, the salary of any retiree who is first reemployed on or after July 1, 2010, as a full-time teacher shall be an amount that is negotiated and agreed to in writing by the retiree and the employer. Such amount need not be based on a salary schedule which accounts for all prior years of teaching service and pertinent experience.

(ii) Notwithstanding any law, rule, or regulation to the contrary, the salary of any retiree first reemployed prior to July 1, 2010, as a full-time teacher and who remains so employed with the same employer shall be governed by the provisions of Subparagraph (a) of this Paragraph or the provisions of Item (i) of this Subparagraph as determined in writing by the reemployed retiree by not later than July

(2)(a) Except as otherwise provided in Subparagraph (b) of this Paragraph, the status of any retiree who is reemployed shall be the same as a full-time active employee and shall be governed by the applicable rules, procedures, policies, and statutes that apply to all such full-time active employees.

- (b)(i) Notwithstanding any law, rule, or regulation to the contrary, any retiree who is first reemployed on or after July 1, 2010, as a full-time teacher shall be employed in accordance with an employment contract and such contract shall terminate not later than the end of the school year. The reemployed retiree and his employer may enter into such a contract for a subsequent school year. During the term of the employment contract, the reemployed retiree may be dismissed or discharged in the same manner as provided by law for a teacher serving a probationary term of employment.
- (ii) The provisions of Item (i) of this Subparagraph shall not be applicable to any retiree who is first reemployed prior to July 1, 2010, as a full-time teacher and who remains so employed with the same employer unless the reemployed retiree determines otherwise in writing by not later than July 1, 2011.
- At any meeting of a city, parish, or local school board, at which the such school board is considering the reemployment of a retiree of this system, the agenda for such meeting shall disclose the following information for each such retiree being reemployed:
 - (1) The retiree's number of years of experience.
 - (2) His proposed salary as a reemployed retiree.
 - (3) The expected duration of his reemployment.'
