Monies appropriated from the fund shall not be used in any fiscal year to displace, replace, or supplant state general fund support for these agencies.

C. Appropriations from the fund in any fiscal year shall be allocated as provided in this Subsection; however, in the event that the amount available for appropriation in any fiscal year is insufficient to provide for such allocations, the amounts allocated shall be reduced proportionately.

(2) Five Million Dollars for the Pennington Biomedical Research Center.

(3) One Million Dollars for the Southern University Agricultural Research and Extension Center."
