Thereafter, the frequency of in-person periodic renewals of the offender shall be pursuant to the provisions

of R.S. 15:542.1.1, based on the determination made by the bureau, comparing the elements of the offense of conviction or adjudication with the elements of the most comparable Louisiana offense, as required by Subparagraph (a) of this Paragraph."
