HB 373 proposes to shorten the maximum length of regular sessions in even-numbered years and limits to 10 the number of matters that are not local or special that a member of the legislature may introduce during such sessions.

II. CONCLUSION

The proposed measure can not be accomplished statutorily.

HB 373 proposes to change the length of legislative sessions and to limit the matters which may be introduced in each legislative session, all of which is established by the constitution. Such changes to the legislative sessions would require constitutional authority.
