AMENDMENT NO. 5

On page 236, between lines 42 and 43, insert the following,

"Payable out of the State General Fund (Direct) to the Minimum Foundation Program to city, parish, or other local public school systems, special schools, lab schools, and charter schools, for Teachers' Retirement System of Louisiana employer retirement contributions

\$ 14,000,000

Provided, however, that of the funds appropriated above for employer retirement contributions, the Louisiana Department of Education shall allocate and distribute an amount to each city, parish, or other local public school system, special school, lab school, and charter school, a pro rata share of the Teachers' Retirement System of Louisiana (TRSL) employer retirement contribution made by such entities."

Rep. Edwards moved the adoption of the amendments.

Rep. Fannin objected.
