For cases tried by a jury, the court shall instruct the jury regarding the presumption if so requested by a party. The court shall not proceed to a trial on the merits until the department has filed with the court the approved feasible plan for the evaluation or remediation of the environmental damage.
- (iii) The party requesting the referral to the department to conduct a public hearing to approve or structure a plan shall be required to deposit with the department sufficient funds to cover the cost of the department's review of the plans or submittals under this Section, including the cost of holding a public hearing to approve or structure the feasible plan. The initial payment of these costs shall be in an amount of one hundred thousand dollars. The initial payment shall be deposited prior to or along with the submission of the plan by the party requesting the referral. The party requesting the referral shall be entitled to reimbursement of any portion of the deposit that is unused by the department.
- (iv) When a public hearing is held following a request pursuant to Item (i) of this Subparagraph, the department shall not conduct an additional public hearing for the same environmental damage.
- (v) The referral to the department to approve or structure a plan pursuant to Item (i) of this Subparagraph shall not apply to claims of environmental damage brought by the state or a local governmental entity unless a party makes a limited admission of liability for environmental damage under Code of Civil Procedure Article 1563, or there has been a determination by the trier of fact that environmental damage exists and a determination that the party or parties who caused the damage or who are otherwise legally responsible for the damage.
