I. SUMMARY OF JOINT RESOLUTION

This report is for Senate Bill No. 216 of the 2014 Regular Session by  
Senator Murray, proposing to amend Art. V, Sections 15(D) and  
22(B) of the Constitution.

SB 216 proposes to authorize the supreme court to reallocate or  
abolish vacant judgeships and to provide procedures to fill vacant  
judgeships.

II. CONCLUSION

The proposed measure cannot be accomplished statutorily.

SB 216 proposes to change the existing constitutional procedure for  
the governor to call a special election for newly-created and vacant

judgeships, and to establish new procedures for the filling, abolition,  
or reallocation of a vacancy in the office of a judge. A constitutional  
amendment would be required to change the existing constitutional  
procedures for filling a vacancy in the office of judge and to  
authorize the reallocation of a judgeship, but the procedures for the  
filling, abolition, and reallocation could be provided by statute once  
constitutional authorization is established.
