To apply to the United States Congress, under the provisions of Article V of the Constitution of the United States of America, for the calling of a convention of the states limited to proposing amendments to the Constitution of the United States of America that address term limits for federal officials and members of congress, election reform, ethics for public servants, financial discipline, states' countermand authority, and other appropriate matters to modernize the constitution and enhance the freedoms, opportunities, and prosperity of the people; to demand that the United States Congress convene the convention within a specific time period leaving all other decisions regarding the convention to the state legislatures and their appointed delegates in the manner provided herein; and to demand that delegates be prohibited from offering and instructed to oppose amendments that weaken the Bill of Rights, limit civil rights, reduce personal freedoms, or create special privileges.

AN ACT

To enact Chapter 2-E of Subtitle II of Title 47 of the Louisiana Revised Statutes of 1950, to be comprised of R.S. 47:340, relative to state sales and use tax; to provide for the levy and collection of a one percent sales and use tax; to provide for the period of time during which the tax shall be imposed; to require the deposit of monies into certain special treasury funds; to establish a special treasury fund; to provide for the deposit, use, and investment of monies in the fund; to provide for the specific highway and bridge projects for which monies from the fund may be appropriated; to provide for an effective date; and to provide for related matters.

AMENDMENT NO. 5

On page 3, at the beginning of line 14, change "(7)" to "(5)"

AMENDMENT NO. 6

On page 4, between lines 15 and 16, insert the following:

The provisions of this Act shall not be construed to authorize any act of discrimination, but are instead intended to prevent the state from discriminating against persons with the deeply held religious belief that marriage consists only in the union of one man and one woman.
