I. SUMMARY OF JOINT RESOLUTION

This report is for House Bill No. 351 of the 2017 Regular Session by Representative Gregory Miller, proposing to add Article I, Section 10(B) and (C) of the Constitution.

HB 351 proposes to prohibit a person convicted of a felony from holding elective or appointive office.

II. CONCLUSION

The proposed measure cannot be accomplished statutorily.

HB 351 proposes to amend the constitution to provide a limitation on the right to seek an elective or appointive office. Such an amendment to the constitution is necessary to limit existing qualifications for statewide elective offices specified in the Constitution.
