Making annual appropriations for Fiscal Year 2017-2018 for the ordinary expenses of the executive branch of state government, pensions, public schools, public roads, public charities, and state institutions and providing with respect to the expenditure of said appropriations.

The commissioner of administration is hereby authorized and directed to reduce up to \$17,900,775 in State General Fund (Direct) contained in each department budget unit in this Act to achieve the funds necessary for an employee compensation plan. The commissioner of administration is also authorized to adjust the other means of financing necessary."
