#### SUMMARY OF JOINT RESOLUTION

House Bill No. 440 of the 2019 Regular Session by Representative Ivey, proposes to amend Article VII, Section 21(F) of the Constitution of Louisiana.

HB 440 proposes to eliminate a contract of exemption for new manufacturing establishments or an addition to an existing manufacturing establishment in favor of a standard and non-standard ad valorem tax exemption for the same. HB 440 proposes a standard exemption of 80% for 7 years. The proposed non-standard exemption would be for a term longer than 7 years with a property tax exemption of more than 80%. The non-standard exemption would be available only to applicants if offered by the governor and approved by the governor, House Ways and Means committee, and Senate Revenue and Fiscal Affairs committee.

HB 151 also eliminates the deductibility of federal income taxes from state income taxes and requires state income tax be established by law. However, HB 151 is dissimilar from HB 441 in that HB 151 does not require the levy of flat individual and joint income tax rate.

HB 260 seeks to make changes to the state income tax similar to those proposed by HB 441.

HB 329 also eliminates the deductibility of federal income taxes from state income taxes and requires that state income tax be established by law. However, HB 329 is dissimilar from HB 441 in that it establishes a maximum rate for individual income tax of three and 28/100 of one percent of net income.
