On page 133, between lines 26 and 27, insert the following:

"Payable out of the State General Fund (Direct) to the Administrative Support Program for operating expenses

\$ 1,772,933

Payable out of the State General Fund (Direct) to the District Support Program for operating expenses

540,997"
